

A Parish Council Meeting was held in the Parish Room on July 2nd, 1935, at 7.30 p.m.

Present: - Messrs Baxter, Garner, Wilkin, and Hindworth.

The Minutes of the previous Meeting were read, confirmed, and signed.

- ① Upon the motion of the Chairman, seconded by Mr Garner, it was resolved that Mr C. Garner be offered the use of the Recreation Ground at a rental of One Shilling and Sixpence per week on the condition (1) that he mow the hemlock and nettles free of cost to the Parish Council, and (2) that he vacate the ground at a week's notice served by the Council at any time that they may see fit for reasons of public policy.

- (p.m.) ② Upon the motion of Mr <sup>Garner</sup> ~~Baxter~~, seconded by Mr <sup>Wilkin</sup> ~~Baxter~~, it was resolved that Mr J. Smith be offered the allotment for which he applies free of rent for one year only. [If the similar offer to Mr F. Butler on p. 57.]

- ③ Upon the motion of Mr Wilkin, seconded by Mr Garner, it was resolved that a letter be sent to the County Council pointing out that the fence of the bridge between the level crossing at Fen Road and the river should be <sup>repaired</sup> ~~replaced~~ at the earliest opportunity; for its present condition constitutes a danger to the public.

- ④ Upon the motion of Mr Garner, seconded by Mr Baxter, it was resolved that a letter be sent to the District Council calling attention to the accumulation of water in the recently cleaned ditch in Butt Lane, which is very likely to overflow and to cause flooding in the event of heavy rain.

- ⑤ Upon the motion of Mr Garner, seconded by Mr Baxter, it was resolved that cheques be drawn in favour of the former Clerk (Mr A. C. A. Taylor), in the sum of Two Pounds, fourteen shillings and sixpence (i.e. salary, £2.8.6.; out-of-pocket expenses,

6s.); in favour of the Waterman, Mr Shipp, in the sum of Nineteen Shillings & sixpence; and in favour of the C.C. Agricultural Officer, in the sum of £7-17-0.

⑥ Upon the motion of the Chairman, seconded by Mr Garner, it was resolved that the question of the appointment of a new Parish Clerk be deferred until the next meeting.

The meeting, the duration of which was 1 1/2 hours, was then closed by declaration of the Chairman.
