A Parish Council Meeting was held in the Parish Room on Thursday, Jan. 16th., 1936, at 7.30 p.m.
Present: - Messrs. F. Baxter, D. H. Eary, J. M. Garrow, Wm. Wilkin, & Dr. R. M. Woodman.

No Minutes were available, as the books were at the R. D. C. Offices for the District Audit. The first business, therefore, was the election of a Chairman of the Council as set out on the Agenda.

Mr. Eary proposed & Mr. Wilkin seconded that Dr. Woodman be Chairman: it was moved "that Dr. Woodman do take the chair," & this formal motion was carried unanimously. Dr. Woodman took the chair & thanked his colleagues.

A six months' notice to quit the Parish Room, given in writing by Mr. G. H. Pearson, was discussed. The Chairman pointed out that the terms of the Agreement between the Council & Mr. Pearson were for a year's notice in writing on either side. Mr. Eary

proposed & Mr. Wilkin seconded, "That Mr. Geo. Pearson be written to & advised that the Council were willing to quit immediately, but that if these terms were not suitable to Mr. Pearson, he be advised that the Council must insist on the full year's notice." The motion was carried unanimously.

The question of the clerkship was then discussed, Mr. Eary taking ^{further} no part in the discussion when a certain name had been put forward. It was unanimously resolved on the motion of Mr. Baxter seconded by Mr. Wilkin "That Dr. Woodman be asked to interview Mr. Sutton with a view to his taking over. With power to act."

The Chairman then declared the Meeting, the duration of which was 35 minutes, closed.
