

A PARISH COUNCIL MEETING was held in the School at 7.30 p.m. on Thursday, Sept. 17 th, 1936.

THERE WERE PRESENT: Dr R.M. Woodman, Chairman (in the Chair), and Messrs J.W. Baxter, J. Halls, and Wm. Wilkin. The Clerk had obtained leave of absence from the Chairman.

THE MINUTES of the previous Meeting were read, confirmed by the Meeting, and signed by the Chairman.

A Letter from the Cambs. C.C. informed the Council that it had been decided to make a FOOTPATH ON THE ELY ROAD from Milton to the Slap Up Inn at a cost of £500. On the proposition of Mr Baxter seconded by Mr Wilkin it was resolved "that thanks be sent to the C.C. for their action in the matter." A circular letter signed by the Chairman of the C.C. and also by the Chairman of the County Committee N.P.F.A. about the KING GEORGE V. NATIONAL MEMORIAL was received.

A cheque was drawn for £4-4-1 to ABRAHAM & SONS of Landbeach for mending THE PARISH SLACKER AND AQUEDUCT ABOVE BAITSBITE LOCK in accordance with a previous Minute (p.89).

Mr Baxter proposed & Mr Wilkin seconded "that the following be paid as they fall due:

1. £2-5-0, being CLERK'S SALARY FOR QUARTER ENDING MICH. 1936.
2. £0-19-6, ... WATERMAN'S
3. £5-0-0, ½-year's RENT ON RECREATION GROUND DUE MICH. 1936 to Miss E.M. Robinson.
4. £7-7-0, RENT ON ALLOTMENTS DUE MICH. 1936 to the County Agric. Officer, less allowce. of 10s. for electricity standards,

& that the CLERK'S & WATERMAN'S SALARIES for the quarter ending Christmas Day, 1936, be also paid as they fall due." This was carried.

THE FINANCIAL STATEMENT SHOWED THE FOLLOWING MONIES RECEIVED:

- i. £1-15-3, from Mr B. Pearson for Bank arrears, due Mich. 1935.
- ii. £4-9-3, Mr Simeon Easy

The Chairman said that he had inspected THE BANK FENCE ERECTED BY MR S. EASY ON AN ALLOWANCE OF RENT, & that he was dissatisfied with it. Another Councillor also said that the fence was not what would be expected. On the proposition of Mr Wilkin seconded by Mr Halls the following was carried: "That the tenant be informed that the Council is not satisfied with the fence, and that it should be made right and continued up to Bankers' Ditch, "as agreed."

The Chairman reported that there was one debtor of the Council, Mr Geo. Unwin. The following resolution proposed by Mr Baxter & seconded by Mr Halls was carried: "That the necessary steps be taken to recover the amount." THE MONEY WAS ALLOTMENT ARREARS.

A motion proposed by Mr Halls & seconded by Mr Baxter was passed: "That NOTICE TO QUIT BE GIVEN TO ANY TENANT OF THE COUNCIL IN RESPECT OF ANY LAND OR PROPERTY ON WHICH THE TENANT IS A YEAR'S RENT IN ARREARS."

It was resolved on the motion of Mr Wilkin seconded by Mr Halls "that the RENTS OF THE BANKS & OF GRAVEL PIT PASTURE BE COLLECTED at Michaelmas as they fall due."

On the question of the DRAINAGE FROM MR PEARSON'S COWSHEDS WHICH WAS ALLOWED TO FLOW INTO THE GRAVEL PIT PASTURE HIRED BY MRS H. COX FROM THE COUNCIL, and which had been adjourned from a previous Meeting so that the Council could examine the field in summer, the following motion, proposed by Mr Wilkin & seconded by Mr Halls was carried: "That a letter be written to Mrs Cox pointing out that the Council strongly disapproved of allowing the drainage

on to Gravel Pit Pasture & that she must on no account allow water or other fluids to be drained on to the land without the written permission of the Council."

An application to erect TWO ADVERTISEMENT BOARDS ADVERTISING TOLLY ALES AND THE STAR BREWERY HOUSES IN MILTON on the RECREATION GROUND by the Star Brewery, Cambridge, Ltd. was refused on the motion of Mr Halls seconded by Mr Wilkin.

It was decided on the proposition of Mr Baxter seconded by Mr Wilkin to ask the School Managers for permission to use the small Schoolroom permanently as a MEETING-PLACE FOR THE PARISH COUNCIL.

The Meeting, which lasted 55 minutes, was closed by declaration of the Chairman.

THE MINUTES of the previous Meeting were read, confirmed by the Meeting, & signed by the Chairman.

In reply to a LETTER from the C.R.D.C. which asked for information as to suitable building sites, the following were suggested: Milton Hall Grounds, Cambridge rd (Mr Winship; Miss E.M.Robinson), Butt Lane (Mr Simeon Easy), & the Recreation Gd (Miss E.M.Robinson). The question of re-zoning the Recreation Ground brought up in a letter from the C.R.D.C. was adjourned. Letters from Miss Warrington (i) re. K.Geo.V Meml Fund, (ii) re. C.R.R.C., & (iii) re. C.R.C.C., were received.

AUTHORIZATION WAS GIVEN TO PAY the following: 5s. to the County Agric. Officer; Mrs Butler's bill, 1s.6d.; the School Managers for hire of rooms, etc.; the pump & War Memorial Attendants, 8s.8d. & 10s. respectively; Clerk's out-of-pocket expenses, 3s.7d.; for two Financial Statements; for the audit stamp; the Commissioners of I.R. property tax; waterman's wage for quarter ending Lady Day, 1937; for any necessary expenditure on elections & forms, etc., by a motion proposed by Mr Easy & seconded by Mr Garner.
