MINUTES OF THE ANNUAL PARISH COUNCIL MEETING HELD IN THE SCHOOLROOM ON TUESDAY THE 26TH APRIL 1938 AT 7.30 P.M.

Present:-

Messrs. F. M. Garner, B. E. Lander, E. J. Walkling, F. Wilson and R. M. Woodman, together with the Clerk.

1. ELECTION OF CHAIRMAN.

Mr. F. M. Garner proposed and Mr. E. J. Walkling seconded "That Dr. R. M. Woodman be re-elected Chairman of the Parish Council for the ensuing 12 months". This was carried unanimously.

2. MINUTES.

The Minutes of the previous meeting were read, confirmed by the meeting and signed by the Chairman.

3. APPOINTMENT OF VICE-CHAIRMAN.

Mr. F. Wilson proposed and Mr. B. E. Lander seconded "That Mr. E. J. Walkling be appointed Vice-Chairman for the year". Carried unanimously.

4. GRAVEL PIT PASTURE.

It was moved by Mr. E. J. Walkling and seconded by Mr. B. E. Lander "That the Council take legal advice regarding the nuisance at Gravel Pit Pasture caused by waste matter from the adjoining premises being allowed to drain thereon, and further that Mr. A. H. Wild be consulted". This motion was carried unanimously.

5. FINANCIAL STATEMENT.

It was proposed by the Chairman and seconded by Mr.

Lander "That the money deposited by Milton (Cambridge) Parish

Council with the Post Office Savings Bank shall be withdrawable

in whole or in part, only on presentation of a copy of a

Resolution passed by the Parish Council and signed by three

Parish Councillors authorising such withdrawal". This

proposition was carried unanimously.

6. MEMORIAL CARETAKER.

The Clerk read a letter from Mr. H. F. Tyrrell resigning his appointment as Memorial Caretaker and it was proposed by Mr. Walkling and seconded by Mr. Garner "That the resignation be accepted". This was carried.

The question of a new caretaker was then discussed and Mr. Walkling moved that the Clerk interview Mr. G. A. Brown of Messrs. Edmunds & Company with a view to ascertaining whether he would be willing to supply at his own expense suitable flowers for planting round the Memorial in place of the grass as at present. In the event of Mr. Brown acceding to this request, Mr. Walkling kindly offered to supply the necessary labour free of charge and Mr. Lander undertook to keep the Memorial tidy and in good order.

The Chairman proposed a vote of thanks to Mr. Walkling and Mr. Lander for their generous offers, and this was seconded by Mr. Garner.

7. PROVISION OF FIRE FIGHTING EQUIPMENT.

An estimate for the provision of fire fighting equipment from the Pyrene Company Limited was discussed and it was proposed by Mr. Walkling and seconded by Mr. Garner "That the estimate be received".

The Chairman reported that the two roods of allotment Plot No. 3a. lately in the occupation of Mr. L. G. Pearce had been let to Mr. H. E. Butler rent free to Michaelmas 1938 and thereafter at a rental of 15/6d. per annum.

The Clerk reported that a new Leather was required on the pump at the Allotments and it was proposed by Mr. F. M. Garner and seconded by Mr. B. E. Lander - "That the necessary repairs be put in hand".

It was also reported that one of the seats erected outside the Cemetery had been pulled up and the Clerk was instructed to have same refixed.

This concluded the business and the Chairman declared the meeting closed.
