

8. PRECEPT.

1. MINUTES.

The Minutes of the previous Meeting were read, confirmed by the Meeting and signed by the Chairman.

2. MATTERS ARISING FROM THE MINUTES.

Rates and Assessments. This matter was adjourned at the last meeting in order that Mr. Walkling might make some further investigations and he reported that the Chesterton Rural District Council had postponed the matter for another two years, but as far as he is aware there will be no alteration in the basis of the assessment.

Fire Brigades Act, 1938. It was reported that Mr. Frederick Coulson and Mr. Thomas Gregg, Junior, had consented to act as Fire Officers.

The Clerk reported the receipt of a letter from the Cambridgeshire County Council to the effect that attention was being given to the Parish Council's suggestion that a white traffic line be painted on the road opposite the former site of the pond. At the time of the Meeting the work had in fact been carried out.

3. APPOINTMENT OF MANAGER FOR IMPINGTON VILLAGE COLLEGE.

The Clerk reported on a letter received from the Cambridgeshire Education Committee requiring the appointment of one Manager from Milton on the Managing Body of the Village College at Impington. It was proposed by Mr. C. P. T. Winckworth and seconded by Mr. F. M. Garner that Mr. E. J. Walkling be appointed Manager. This was carried unanimously.

4. FINANCIAL STATEMENT.

The Clerk reported the receipt of £4. 9s. 3d. being rent of Banks due from Mr. S. Easy at Michaelmas 1938.
