The Clerk was accordingly instructed to advertise the termination by the Council of the hire of the Recreation Field.

After a discussion the Clerk was instructed to write to the organisers of the Rural Pie Scheme for full particulars and when these had been received to approach the Women's Institute with a view to their undertaking distribution in the village.
