

REPORT OF PUBLIC MEETING HELD IN THE BRITISH LEGION HALL ON  
WEDNESDAY 29TH MAY, 1946 AT 8 P.M.

RE RECREATION GROUND AND VILLAGE HALL.

Dr. R.M. Woodman in the Chair.

After a discussion Mr. A.W. Wenham proposed and Mr. D. Pearson seconded "That a fund be started for the purpose of acquiring a Recreation Ground and a Village Hall". Carried unanimously.

The Chairman proposed and Mr. D. Pearson seconded "That a Committee, to be called 'The Planning and Building Committee' be formed, and that this Committee should represent as many interests in the village as possible". Carried unanimously.

It was agreed that the following bodies or groups should appoint members to the Planning and Building Committee:

It was also agreed that the Planning and Building Committee should have power to co-opt 3 persons.

It was agreed that the Planning and Building Committee appoint its own Honorary officials.

Mr. Leslie Coulson was appointed Honorary Secretary pro tem on the strict understanding that the Committee, when it met, would appoint someone else as the permanent Honorary Secretary.

RESIGNATION OF WATERMAN. The Clerk read a letter from Mr. B. Shipp  
resigning his position as Parish Council Waterman as from Michaelmas  
1946. The Chairman proposed and Mr. L. A. Easy seconded that a  
letter of thanks and appreciation be sent to Mr. Shipp for the  
splendid way he had performed his duties over a period of 30 years.  
This was carried unanimously.

Regarding a successor, the Clerk was  
instructed to advertise on the Parish notice board for a Waterman at  
a quarterly salary of £1.

1914 - 1918 War Memorial. A letter from the Secretary of the  
British Legion (Milton Branch) complaining of the dilapidated state  
of the Memorial was considered. The Clerk was instructed to approach  
Mr. Lander to see whether he would be willing to again act as  
caretaker of the Memorial.

SUPPLY OF DUSTBINS. A letter from the Chesterton Rural District  
Council concerning the supply of dustbins was considered and it was  
agreed that this be posted on the notice board and anyone who  
required to take advantage of the offer should communicate with the  
Clerk.
