

COLLECTION OF RUBBISH. The Clerk reported that he had been approached by a parishioner with a view to the C.R.D.C. extending their route for collection of rubbish as far as the river in order that the householders at Baitsbite Locks might avail themselves of the service provided. It was decided that this was a matter for the individual concerned applying personally to the Rural District Council.

Another application from the same parishioner for a road sign direction to Baitsbite Locks was also considered and here again the Clerk was instructed to reply that this was a matter for the County Council Roads and Bridges Committee.

On the proposition of Mr. A. W. Wenham seconded by Mr. F. Wilson the Clerk was instructed to communicate with the Roads and Bridges Committee asking that the existing pathway be extended for this short distance. At the same time he was to draw attention to the large puddle which formed over the pathway immediately outside the Chapel, and to enquire whether this also could have attention.

The seat erected on the path near the Men's Institute was reported by the Clerk to have been damaged and after discussing the matter he was instructed to get an estimate for repairing and refixing.

This concluded the business and the Chairman declared the meeting closed.

MINUTES. The Minutes of the previous meeting were read, confirmed by the meeting and signed by the Chairman.

MATTERS ARISING FROM MINUTES. Waterman - The Clerk reported that no applications had been received in response to the advertisement for the post of Waterman. As he had been regulating the water in the meantime he agreed to continue doing so until such time as he could find a regular Waterman. It was unanimously agreed that while he executed these duties he should receive the Waterman's salary of £4 per annum dating from 29th September, 1946. The Clerk reported that he would require a Crome in the course of these duties and was instructed to procure one.

1914-1918 Memorial - The Clerk reported that Mr. Lander had agreed to act as caretaker on the War Memorial and on the proposition of Mr. F. Wilson seconded by Mr. J. Russell it was unanimously agreed that a letter of appreciation be sent him.

It was reported that the County Surveyor had attended to the Council's request for an extension of the pathway from Milton Laundry and also had improved the pathway outside the Chapel. On the proposition of Mr. J. Russell seconded by Mr. L. A. Easy the Clerk was instructed to thank the County Surveyor for his prompt attention.

Confirmation was received of the Chairman's action in accepting Messrs. Mortlock's estimate of £2 for repairing and refixing the seat outside the Men's Institute.

MILTON BUS SERVICE. The Chairman reported that although a notice inviting complaints as to the inadequacy of the bus service had been posted on the notice board none had been forthcoming. It was generally felt that Milton was badly served by the Eastern Counties Omnibus Company and the Chairman agreed to write direct to the Head Office at Norwich complaining of the deplorable service and requesting that considerable improvement be effected immediately.
