MINUTES. The Minutes of the previous meeting were read, confirmed by the meeting and signed by the Chairman.

MATTERS ARISING FROM MINUTES.

Civic Restaurant. A letter was received from the Milton Women's Institute to the effect that owing to the close proximity of Cambridge a Civic Restaurant was not needed. It was therefore decided not to proceed further in the matter.

The Chairman reported that a sewage scheme for Milton had been prepared by the Chesterton Rural District Council and was being sent to the County Council.

IMPINGTON VILLAGE COLLEGE. It was unanimously agreed that Mr. J. Russell be re-appointed representative on the Governing Body of Impington Village College.

WAR MEMORIAL. A letter was received from the Milton British Legion Branch requesting that consideration be given to the addition of names on the War Memorial of those men who had lost their lives in the 1939-1945 war. During discussion it was pointed out that the Parish Council were not empowered to expend money for this purpose. "That the Parish Council have no objection to Milton British Legion taking the necessary steps to have the required names engraved on the War Memorial" was the proposition of Dr. R. M. Woodman, which proposition was carried unanimously.

C.R.D.C. HOUSING PROGRESS. The Clerk presented the C.R.D.C. Housing Progress Report for quarter ending 31st December, 1947. This showed that a site of 3.490 acres had been acquired in Milton; possession of which had not yet been taken. The Chairman reported that it had been provisionally agreed to erect 8 houses.

BILLS FOR PAYMENT. On the proposition of Mr. D. Pearson, seconded by Mr. A. A. Easy the following bills were authorised to be paid:

ANY OTHER BUSINESS. The Clerk was instructed to write to the Cambridge University & Town Gas Light Company asking if the gas main could now be extended to Milton as in the opinion of the Council there was a good demand for a gas supply.

DISTRIBUTION OF FOODSTUFFS FROM THE DOMINIONS. A letter was received from the Chesterton Rural District Council intimating that a consignment of gift foods had been received for distribution to necessitous cases. This food had been allocated between parishes on a population basis, the allocation to Milton being as follows:

6 x 1 lb.	tins Bacon.
2 x 1 lb.	" Dripping.
40 x $\frac{1}{4}$ lb.	" Meat.
13 x $2\frac{1}{2}$ lb.	" Honey.
4 x $1\frac{1}{2}$ lb.	" Jam.

After a long discussion a list of recipients was prepared, preference being given to the sick and infirm, the aged and those living alone. In all a total of 25 families received a share, the Clerk being responsible for the distribution.

This concluded the business and the Chairman declared the meeting closed.
