The Clerk was instructed to ask permission of the County Council to expend a rate of up to 11/3 pence in the £ on the maintenance of the War Memorial.

Recreation Ground. Following on the Council's inspection of suitable sites for a Recreation Ground-when it was decided to approach Cambridgeshire Town & Country Planning Authority as to the possibility of purchasing Plot No. 19 on Cambridgeshire Sheet XL 11, 2nd edition 1903, which is the pasture field adjoining Benet Farm on the southwest side. In view of information received from the Manager of the Fens Sub Area British Electricity Board it was agreed that the matter of acquiring a Recreation Ground should be held in abeyance for the time being.

Consideration was given to the suggestion put forward BANKERS DITCH. by the Chesterton Rural District Council to fence along Bankers Ditch for the whole length of the Banks and so prevent cattle from treading in the ditch. It was felt that the suggestion was impracticable bearing in mind the low rental received, the considerable length of fencing required, the extreme difficulty of satisfactorily erecting a fence between the foot of the bank and the water's edge and the continual cost of maintenance. The Clerk was instructed to reply on these lines.

WAR MEMORIAL - ADDITION OF NAMES. An estimate from Messrs.
