In connection with future lettings of the Charity Trustees! PASTURELAND, Mr. G. H. Pearson suggested that instead of letting for a period of 3 years as at present, future lettings should be on an annual basis. The Chairman promised that this suggestion would be carefully considered by the Trustees.

MILTON VILLAGE HALL PLANNING AND BUILDING COMMITTEE. Mr. A. W. Wenham gave a resume' of the Committee's progress. He reported that £89 had been raised during the past year, bringing the accumulated fund up to £507.

Strenuous efforts had been made towards acquiring a recreation ground, but to no avail. However, it was now learned that there was every prospect of the village being able to share a recreation ground with the Eastern Electricity Board, and in consequence it had been decided to concentrate efforts towards acquiring a site for a Village Hall and Children's Phayground. The Chairman expressed appreciation of the efforts made by the Committee .

APPOINTMENT OF REPRESENTATIVES TO MILTON VILLAGE HALL PLANNING AND BUILDING COMMITTEE. It was unanimously agreed that Mrs. W. Burling and Messrs. L. Edwards, W. Shipp and S. A. Siggs be re-appointed members of the Committee.

This concluded the business and the Chairman declared the meeting closed.
