ELECTION OF CHAIRMAN. Mr. E. J. Walkling was unanimously elected Chairman for the ensuing year on the proposition of Mr. D. Pearson seconded by Mr. C. W. Langley. Mr. Walkling Mr. E. J. Knights, Manager of The Eastern Electricity Board Fens Sub-Area, who had promised to clear the outlet from the lake in an endeavour to ensure a quicker flow. Mr. Pearson undertook to clear the ditch from the lake sufficiently to receive the outflow.

National Association Conference. This matter was adjourned to the next meeting.

PLAYING FIELDS ASSOCIATION - Annual Meeting. The Annual Meeting was arranged for 3rd June, 1949 and Mr. S. A. Siggs was appointed delegate to attend.

Mr. S. A. Siggs as Chairman of the Panning VILLAGE HALL SITE. and Building Committee reported on the negotiations for the purchase of a site for a Village Hall and Childrens' Playground. To date, Miss E. M. Robinson, the owner of the proposed site known as The Green, had flatly refused to negotiate the sale. It was felt that as the Planning and Building Committee's suggestion for the development of this particular site. coincided with that of the County Planning Committee, a letter from the County Planning Officer to Miss Robinson might help persuade her to negotiate. It was therefore agreed that Mr. Siggs pursue this course.

WAR MEMORIAL. The Clerk reported that Messrs. Ivett & Reed would complete the engraving of the War Memorial in time for any unveiling ceremony which it might be desired to arrange. discussion it was agreed that the unveiling ceremony be held on Whitsunday, 5th June, at 3.0 p.m. and that an invitation be extended to the Milton Branch British Legion for one of their members to perform the actual unveiling. Arrangements were left to Rev. J. M. Plumley and the Clerk.

The state of the footpath outside the Petrol Pumps was reported to be in a very rough condition due to cars running over it to an from the pumps. The Clerk was instructed to draw this matter to the attention of the County Surveyor and suggest that a proper kerb be laid to keep cars within bounds.

It was thought that an additional postbox was required in the vicinity of the Petrol Pumps. The Clerk was instructed to forward this suggestion to the Postmaster.

It was agreed that the next meeting be held on Tuesday, 7th June, 1949.

This concluded the business and the Chairman declared the meeting closed.
