MILTON FIROCHIAL CHARITIES ACCOUNTS.

The Clerk to the Trustees presented the accounts for the year ended 31st December. 1949, and after examination these were unanimously adopted.

MILTON VILLAGE HALL PLANNING AND BUILDING COMMITTEE. The Chairman of the Planning and Building Committee gave a brief resume of the Committee's activities during the past

year. These had resulted in a profit over the year of £62, bringing the total accumulated funds to approximately £570. Although licences for building Village Halls had been suspended, it was deemed desirable to continue activities in order that should there be an opportunity in the future to develop a playing field or village hall sufficient funds would be available to meet initial expenses. The County Planning Committee had in fact granted permission for the erection of a village hall on the Green. although it had not been possible to acquire the site.

APPOINTMENT OF REPRESENTATIVES TO MILTON VILLAGE HALL PLANNING AND BUILDING COMMITTEE.

It was unanimously agreed that Mrs. W. Burling. and Messrs. L. Edwards. W. Shipp and S. A. Siggs be re-appointed representatives from the parish on the Village Hall Planning and Building Committee.

APOLOGIES for absence were received from Mr. C. W. Langley and Rev. J. M. Plumley.

MINUTES. The Minutes of the previous meeting were read, confirmed by the Meeting and signed by the Chairman.

A letter was read from the County Planning Officer intimating that the County Planning Committee contemplated granting permission to the Landbeach Sand and Gravel Company to use for gravel extraction part of 0.3.P. 149, Cambridge Road, Milton. Before granting permission they asked for the observations of the Council. Accordingly the matter was discussed by the Council and it was unanimously agreed to object in the strongest possible terms to any additional land in Milton being used for the purpose of extracting gravel. The Clerk was instructed to reply to this effect.

PUBLIC PUMPS. The Chesterton Rural District Council confirmed a recommendation of the Public Health Committee that where a piped supply of water was available the repair of public pumps should be discontinued. Accordingly as from 30th November, 1950, the repair of the pumps at the War Memorial and the Council Houses would cease. The Purish Council, however, decided to continue maintaining as heretofore the pump at the War Memorial.

Was received intimating that should any relaxation of existing restrictions on capital investment works make it possible to reconsider the scheme for Milton, the Council's representations would be borne in mind.

This concluded the business and the Chairman declared the meeting closed.
