The Minutes of the previous meeting were read, confirmed by the meeting and signed by the Chairman.

Resignation - Mr. L. A. Easy.

The Clerk reported that he had communicated with Mr. Easy as to his non-attendance at meetings for a period of seven months, and he verbally signified his resignation. This was accepted with regret.

The question of filling this vacancy was discussed and in accordance with the Council's policy of inviting unsuccessful candidates from the last election, the Reverend J. M. Plumley proposed that Mr. J. Russell be invited to serve on the Council. This proposition was seconded by Mr. C. W. Langley and carried unanimously. It was further agreed that if Mr. Russell declined to serve, then the invitation should be extended to Mr. J. Bradnam.

Billeting and Care of the Homeless.

The Ministry of Health desired that local authorities take steps to implement the provisions of the Civil Defence Act, 1948, relating to Billeting and Care of the Homeless. Accordingly, it was necessary to form a local Billeting Committee and appoint a suitable person to act as Billeting Officer in a voluntary capacity. After discussion it was agreed to invite the Women's Institute to appoint two of their members to serve as local Billeting Committee with the Reverend J. M. Plumley and Mr. A. W. Wenham. As regards a Billeting Officerit was agreed that Mr. J. Bullen be asked to act in this capacity. Suggested suitable premises which could be made available for the reception of evacuees pending distribution to houses were The Canteen at Milton Hall and Milton Men's Institute.

Proposed Greyhound Race Track, Landbeach Road, Milton.

An Inquiry into an appeal by Mr. T. V. Easy,
Sandhurst, Landbeach, against the refusal of the Cambridgeshire County Council to permit the use of a field in the
parish of Milton for the purpose of a Greyhound Race
Track and the erection of the necessary buildings, was to
be held at the Shire Hall on 3rd April 1951. The field being
No. 7 on the Ordnance Map and situated about 350 yards
west of the house known as Sandhurst. This matter was
considered and Mr. C. W. Langley proposed that a letter
be sent to the County Council opposing the proposal.
The Reverend J. M. Plumley seconded the proposition which
was carried unanimously. The Clerk was thereupon instructed
to send a letter setting out the grounds for opposition to
the Scheme.

Impington Village College - Managing Body.

Mr. S. A. Siggs was unanimously re-elected as representative on the Managing Body of Impington Village College.

Allotments.

Complaints had been made about the non-cultivation of one acre of allotments in the occupation of Mr. T. Housden. It was agreed that the Clerk should interview Mr. Housden and warn him that unless he cultivated the ground the Council would have no option but to serve a notice to quit.
