MATTERS ARISING FROM MINUTES.

Public Footpaths - The Clerk reported that the plan showing public footpaths had been returned to the County Council, who would submit this to the Rural District Council for their observations. It would thereafter be returned to the Parish Council for submission to a special Parish Meeting for final approval.

Street Lighting - The Rural District Council had decided that the request for additional street lighting could not be included in their 1952 financial estimates.

Naming and Numbering of Streets - The Rural District Council decided not to make any provision for this in their 1952 financial

Footpath, Cambridge Road .- The Clerk reported a reply from the County Council that if funds were available the footpath from Messrs. Edmunds to Bene't Close would be constructed.

Fen Road Drain - The Chairman reported on meetings he had had with both the County Council and Rural District Council Engineers and on inspections he had made of the ditch in Fen Road. result of these was that the County Council had agreed to relay the drain in Fen Road during the coming financial year, and the Chesterton Rural District Council to clean out the ditch in Fen Road in the very near future. They contended that the amount of sludge in this ditch largely accounted for the flooded conditions

Seat, Bene't Close - The Clerk reported that he had agreed a site with the County Council Divisional Surveyor for the erection of a seat near Bene't Close bus stop, and was awaiting written confirmation from the County Council before proceeding with the
