### 136/04 7 Youth

The minutes of the Youth Committee meetings of 11 and 23 March were received. Noted that the tender return date was now 21 April.

The appointment of a Planning Supervisor (legal requirement) at a cost of £500 during the construction of the youth building was **CONFIRMED** – to be paid from the remainder of the portacabin capital fund – 10 votes in favour and 3 abstentions.

#### 138/04 9 Roundabout near Tesco

A letter from Bob Menzies of the County Council commented that the signs should not distract motorists and that there was no record of safety issues being attributed to them.

He apologised for not consulting the Parish Council and had no record of the Parish Council having a 'Licence to Cultivate'.

The County Council presently received no revenue from Marketing Force in respect of the sponsorship. The benefit received was enhanced maintenance at no cost.

#### **AGREED**

to write to Brian Smith Director of Environment and Transport asking that that the signs be removed and pointing out that:

- 15 roundabouts had been identified at the South Cambs Environment and Transport Area Joint Committee meeting dated 10 March 2003. The roundabout at Milton was not one of them
- This roundabout had been receiving "enhanced maintenance" for
   13 years 18 cuts during the year at no cost to the County

  Council
- The signs on such a small roundabout were prominent and a distraction to motorists and as such contravened the "Traffic Signs and General Directions" regulations. If the signs had been designed that they "..should not distract motorists" then the advertisers were not getting value for money as the objective of advertising is to attract our attention.

The clerk would enclose a copy of the Licence to Cultivate and relevant correspondence.

#### 140/04 11 MCC Update

Main meeting 5 May. Finance, Recreation and Buildings committees were due to meet. The Buildings committee would look at the Community Centre refurbishment and extension, the present and proposed youth buildings.

Cornhill were refusing to insure the garage and store at The Sycamores as from 1 October unless an adequate alarm system was installed. MCC were investigating ways of solving this problem.

## 142/04 13 County Councillor's report

<u>Highways</u> - S Mallott and other staff had left the employment of the County Council. Matters in hand: the poor state of Cambridge Road / High Street and the speed hump, new signs to entrance of village and 30mph roundels.

Northern Fringe – JEC was trying to arrange a meeting for 28 April.

Crane Industrial Estate – the site was being cleared.

<u>Street Light</u> – behind 130 The Rowans was now installed. The clerk reported that SCDC had approved a grant of £271.17.

<u>Cycle Bridge</u> – opening date to be made known on 6 April. Landscaping would take place in the Autumn. SCDC were looking into improving the entrance to the Country Park. Planting schemes for the industrial estate road had not been approved.

<u>Guided Bus</u> – over 1000 objections had been received.

<u>Crime Figures</u> – received but no details included. It was suggested that Council should write to the police expressing concern over the lack of communication about the recent damage that occurred during a wedding reception and the presentation of the unsatisfactory crime figures. Concern was expressed about Council's commitment to crime prevention.

## 143/04 14 District Councillor's report

<u>Field adjacent A14/Tesco</u> – a proposal to build a restaurant/hotel on this land was being put forward.

<u>Kitchen Waste Bins</u> – SCDC were proposing to include kitchen waste in the green bin collection and to provide mini bins for the kitchen on demand. It was **AGREED** to ask SCDC to deliver bins to the Village Fayre on 11 July for distribution.
