Minutes of the Annual Parish Council Meeting of Monday 12 May 1986 at 7.30pm in the Community Centre.

Present: Mrs. B.C. Waterson (in the chair), R. Day, A.D.J. Bull, W.D. Booth, R.J. Farrington, Mrs. L.M. Lock, P.D. Rice and the clerk S.J. Daniels.

Mr. R. Meek and Mr. P. Symonds.

Apologies were received from P. Harrold, G. Patten and Mrs. J. Westwood.

### I. COUNCIL BUSINESS

- 1. 6727 B.C.W. welcomed Robin Farrington who signed the declaration of acceptance of office as councillor.

  It was noted that H.A.C. had resigned. The clerk would write him a letter of thanks for his work whilst on the Council.
- 2. 6728 Country Park. R. Mesk explained that in order to apply for grant aid it was necessary to obtain planning permission for the Country Park. Application for compulsory purchase order certificates were being made (5/0739/86). Council fully supported this. There would almost certainly be a public inquiry probably in May, 1987. The land owned by Mr. Stokes and Mr. Marsh was necessary for the whole scheme and R.M. was wary of phasing the Park. Details of the Park would need to be negotiated with the various owners and R.M. agreed that a Working Party could be organised. Traffic would be heavier, he suggested, at weekends. Concern was expressed about the access points. Council felt it unnecessary to show these on a map if they were meant for villagers' use. R.M. would discuss the details of whether to mark these points on a map at the appropriate time. The vehicle access in Old School Lane was necessary as it was used by the University Sailing Club. The "Country Parks" Act offered protection against commercialisation by its wording viz. "for leisure activity." S.C.D.C. had no intention of setting up caravans, restaurants etc.
  - B.C.W. thanked both Mr. Symonds and Mr. Meek for attending.
- 3. 6729 Election of Chairman. B.C.W. was proposed by A.D.J.B. and seconded by R.D. All agreed.
- 4. 6730 Signing of Declaration. B.C.W. signed the declaration of acceptance of office.
- 5. 6731 <u>Vice-Chairman</u>. It was agreed to leave this election until the next meeting.
- 6. 6732 Appointment of Representatives.
  - a) Milton School Governors: R.D. had resigned. P.D.R. proposed L.M.L. as governor and W.D.B. seconded. All agreed.
  - b) Impington Village College: J.W. had now agreed to continue as governor if elected. R.D. proposed and A.D.J.B. seconded her agreed.
  - c) Milton Community Centre: It was agreed that L.M.L. should continue.
  - d) Play Committee. R.D. has resigned. It was agreed to leave this committee at three members.
- 7. 6733 Minutes of the meeting of 7th April 1986 having been circulated were confirmed and signed.

## 8. Matters Arising.

6734 <u>Landbeach Road/A10 Junction</u>. Following the recent serious accident (6676) it was agreed to ask the Director of Transportation for various

- signs to try to make drivers more aware of this dangerous junction.
- 6735 Play Areas. Mr. D. Buck had advised Council to continue pressing (6710) for very small play areas for toddlers. A meeting was arranged for Friday 16 May with S. Sillery and the developers.
- 6736 <u>Seat</u>. Nothing further had been heard from British Rail. (6712)
- 6737 Minibus Scheme. The clerk had received a phone call from a (6715) parishioner willing to offer a minibus and possibly a driver. Council were very grateful for the offer and thought that Thursdays after the Lunch Club had met would be an appropriate time for the shopping expedition.
- 6738 <u>Cemetery Hedge</u>. R.D. had dealt with the hedge around the (6717)cemetery extension.

#### 9. 6739 Community Centre.

- a) Constitution. L.M.L. had made some progress with the Charity Commissioners. Legally the name "Milton Community Centre" did not exist, although there was nothing to prevent this name being used. All correspondence should officially be addressed to the M.V.H.R.G.M.C. Only the M.V.H.R.G.M.C. could apply to change the trusts. The Charity Commission would then draw up the new trusts to be sent to M.V.H.R.G.M.C. for approval. If the M.V.H.R.G.M.C. accepted these new trusts they would then need to be advertised in the village for one month. The C.C. would seal the scheme providing that there were no objections. Council was allowed to donate the services of the treasurer and manager but they should be appointed by M.V.H.R.G.M.C. . These officers would look to that committee not Council for instructions.
  - As the newly elected chairman of this committee L.M.L. would call a meeting to discuss the amendments as proposed by Council.
  - b) <u>Superannuation</u>. It was understood that Mr. Morgan wished to continue in the superannuation scheme. A letter from the County Council outlined the necessary information.

    L.M.L. proposed R.D. seconded and all agreed that the following resolution be passed: "That from April 15th 1986 Rex Morgan be specified as a pensionable employee under Regulation B 1(5) of the Local Government Superannuation Regulations 1986. That all necessary steps be taken in conjunction with the Cambridgeshire County Council, the appropriate superannuation fund authority, to carry the resolution into effect." The clerk would find out the position re: sick pay.
  - c) Grant. R.F. proposed R.D. seconded and all agreed that a grant of £2000 be paid to the Community Centre plus a quarterly payment of £2000 towards the manager's salary. (bunch would also consider large thems of capital expenditure d) Report. A letter from Willmott explained that the poor weather caused delays in restoring the ground. S.B.P. had in hand the problems as yet unresolved.

    The report of the Environmental Health Officer had been received. His recommendations were being dealt with. Willmott's 7th valuation of £10,049 had been paid making a total of £231,475. and leaving the retention fee of £3525.

A letter of thanks from the Carpet Bowls Club was received. Mrs. Coston had negotiated a 10% discount and 12 interest free payments.

- e) Opening. The M.V.H.R.G.M.C. would be encouraging another fair on July 5th. R.D. proposed P.D.R. seconded that Francis Pym be invited on that day to open the Centre officially. All agreed.
- f) Gratuity. A.D.J.B. proposed R.F. seconded and all agreed that Council pay up to £150 towards a gift for S.B.P. who had saved the village a considerable amount of money. The gift would be presented on 5th July.
  R.D. and R.F. would find a suitable gift.
- g) Old Hall. An offer of £50 for the old hall had been made by Peter Cornish. A.D.J.B. proposed L.M.L. seconded and all agreed that Council accept this offer.
- 10. 6740 Tennis Club Request. It was agreed to defer this item and the review of the clerk's salary till the next meeting.
