MATTERS ARISING FROM MINUTES.

Ditch at rear of Coles Road - Enclosed with a letter

864.

from the County Land Agent was a sketch taken from the Enclosure Award of the Parish of Milton, dated 1802, which indicated that the ditches adjoining the respective fields were in the same ownership as those fields. The present responsibility for maintaining these ditches appeared to present a highly complicated legal situation and in consequence it was agreed that the Chairman, together with Mr. Forbes and Mr. Wenham, should meet the County Surveyor on the site to discuss the matter.

<u>Village Hall Site</u> - Messrs. Douglas January and Partners, on behalf of Messrs. Kirk (Cambridge) Limited, submitted a firm offer of £1,200 for the Village Hall site.
