MINUTES.

The Minutes of the Annual Parish Meeting held on  
27th March 1956, were confirmed and signed.

253. PARISH COUNCIL ACCOUNTS.

The Clerk of the Parish Council presented the  
Accounts for the year ended 31st March, 1956. These were  
examined and on the proposition of Mr. A. C. Daniels,  
seconded by Mr. S. A. Siggs, were unanimously adopted.

254. MILTON PAROCHIAL CHARITIES ACCOUNTS.

The Clerk presented the accounts for the year ended  
31st December, 1956, and explained that out of a total  
distribution of £74. Os. Od., the Village Fund received  
£32. Os. Od., which was distributed in the form of food  
parcels to 31, widows, widowers and old age pensioners as  
selected by the Trustees.

After examination the accounts were adopted on the  
proposition of Mrs. D. Pearson, seconded by Mr. A. C.  
Daniels.

255. CHAIRMAN'S REPORT.

The Chairman gave a resume of the Council's work  
throughout the year, and this met with general approval.

256. MILTON SCHOOL.

Mrs. L. F. Coulson, one of the Parish Council's  
representatives to Milton School Managers, reported that  
the County Architect had received tenders for the  
erection of the new school. These were to be considered  
by the Education Committee at the end of March and, if  
acceptable to the Ministry of Education, then building  
would commence without further delay.

There were at present 53 pupils on the school  
register, but numbers were likely to decrease slightly  
and the Education Committee had intimated that the staff  
would be reduced to two at the end of the Spring term.

Parents present protested strongly at this reduction in staff and considered that the education of their children had suffered by reason of the frequent changes in teachers during the past year and recommended that the County Education Department be urged to allow the school to remain a three teacher school.

IMPINGTON VILLAGE COLLEGE.

Mr. S. A. Siggs presented a report as the Council's representative on the Managing Body of Impington Village College. He remarked that the keenness of the Warden and his staff was generally reflected in the pupils, who were given every encouragement to make the most of the opportunities afforded by the College. Although some classes number up to 45 pupils, individual attention was given and there were special classes for the slow developers. The Grammar school stream was proving a success and the coming September would see the original pupils entering their fourth and final year before taking their General Certificate of Education.

This concluded the business and the Chairman declared the meeting closed.
