ELECTION OF CHAIRMAN.

On the proposition of Mr. D. Pearson, seconded by
Mr. A. Wayman, Mr. E. J. Walkling was unanimously

MATTERS ARISING FROM MINUTES. Recreation Ground.

The Clerk submitted a private and confidential
letter from the County Planning Officer which stated
that the District Valuer considered that on the information
available to him the cost of acquiring the site for the
recreation ground would be of the order of £3,500 under
the terms of the new Town and Country Planning Bill, but
until the Bill had been passed by Parliament it was not
possible to give a final estimate. The County Council
therefore, were not in a position to state the amount of
grant which would be available. On the proposition of
Mr. L. Maxwell Forbes, seconded by Mr. A. W. Wenham, it
was unanimously agreed that the matter be left until the
amount of grant which would be available was known.

APPOINTMENT OF VICE-CHAIRMAN.

HOUSING DEVELOPMENT.

The Clerk submitted the layout plan of the proposed housing development as received from the County Planning Officer. After careful consideration it was agreed the following observations be sent to the Planning Officer:-

- (i) The surface water was to be discharged into a private ditch. What steps were to be taken to maintain this ditch in a fit state, and at whose expense?
- (ii) Concern was expressed as to possible flooding in the lower reaches of this private ditch.
- (iii) Concern was expressed as to whether the site could be adequately sewered in view of the County Council's reluctance in the past to build the new school on part of the site.
- (iv) Who would be responsible for keeping tidy the grass verges fronting the houses?
- (v) How many houses per acre are proposed?
- (vi) Could designs of the different types of dwellings be submitted for consideration?
- (vii) Has the proposed development received Planning approval?
- (viii) When is it proposed to commence development?

It was also agreed that a representative from the County Planning Department be invited to the next Council Meeting.

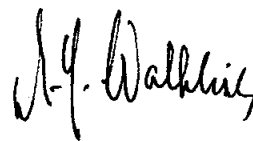
