994. APOLOGY FOR ABSENCE.

995. ELECTION OF CHAIRMAN.

On the proposition of Mr. L. M. $^{\rm F}$ orbes, seconded by Mr. J. S. Doggett, Mr. D. Pearson was unanimously elected Chairman for the ensuing year. Mr. Pearson thereupon signed a declaration of acceptance of office.

Mr. L. M. Forbes was unanimously appointed Vice-Chairman on the proposition of Mrs. D. Pearson, seconded by the Chairman.

997. APPOINTMENT OF REPRESENTATIVE TO MILTON VILLAGE HALL AND RECREATION GROUND MANAGEMENT COMMITTEE.

The appointment of the Chairman as representative member and Messrs. L. M. Forbes and A. W. Wenham as elected members to Milton Village Hall and Recreation Ground Management Committee for the year 1965/66 was confirmed.

MATTERS ARISING FROM MINUTES.

Ditch at Coles Road - The Clerk reported that he had received a letter from Messrs. EQUIPMENT FOR RECREATION GROUND.

An offer by Milton Football Club to pass over to the Parish Council goal posts and all ancillary equipment was gratefully accepted, a proviso being that should the Milton Football Club cease to play their matches on the recreation ground, then such equipment would be returned to the Club; the Council not being responsibile for any wear and tear off equipment meanwhile.

CHURCH LANE.

A complaint was received from Milton Parochial Church Council as to the condition and level of the road surface.

The Clerk was instructed to bring this to the notice of the County Surveyor, at the same time requesting that the pathway be extended to the new houses in Church Lane.

FEN ROAD.

The Clerk was instructed to request the County Council to extend the footpath on the north side of Fen Road as far as Goding Way.

1017.

LITTER BINS.

It was agreed that the litter bins at the two bus shelters be renewed, and an additional one purchased for erection near the War memorial.

1018.

RECREATION GROUND.

A discussion arose regarding the cutting of the recreation ground and Mr. L. M. Forbes agreed to negotiate with the County Council for regular cutting to be undertaken. Failing a successful outcome of these megotiations it was unanimously agreed that the Council purchase a gang mower

1019.

Mr. Forbes reported that a revised estimate had been received for the new Village Hall, which now included changing rooms. The estimate amounted to approximately £12,000. The cost of furnishing and equipment would add at least £1,500 making a total of between £13,500 and £14,000.

The Village Hall and Recreation Ground Management Committee could make available approximately £3,500 and it was necessary for the Parish Council to accept the responsibility for a loan of £3,500.

On the proposition of Mr. J. S. Doggett, seconded by Mr. J. W. R. Lewis, authority was given to Mr. Forbes to negotiate a loan on behalf of the Parish Council in an amount of £3,500 on the best terms available.

SALE OF OLD VILLAGE HALL.

On the proposition of Mr. L. M. Forbes, seconded by Mrs. D. Pearson, it was agreed that the Milton Girl Guides and Boy Scouts Associations be offered the old Village Hall at a nominal figure of £1, with the following provisos:

- (a) the site to be properly cleared,
- (b) planning permission for re-erection on the Recreation Ground to be a matter between the County Planning Authority, the Scouts and Guides Associations and the Village Hall and Recreation Ground Management Committee.
- (c) the Prish Council to be in no way responsible for any costs involved in dismantling and the re-erection of the building.

This concluded the business and the Chairman declared the meeting closed.
