MINUTES.

The Minutes of the Annual Parish Meeting held on 28th March, 1961, were read, confirmed by the meeting and signed by the Chairman.

741. PARISH COUNCIL ACCOUNTS.

The lerk presented the Parish Council Accounts for the year ended 31st March 1961. After examination these were unanimously adopted.

742. MILTON PAROCHIAL CHARITIES ACCOUNTS.

The Clerk presented the accounts of Milton Parochial Charities for the year ended 31st December, 1961. A total of £78 has been distributed as follows:-

The proportion due to the Village Fund was distributed in the form of coal, 34 agreed recipients each receiving 2 cwts.

The accounts were unanimously adopted.

43. VILLAGE HALL MANAGEMENT COMMITTEE.

Mr. John Day was elected representative to the Village Hall Management Committee for the ensuing year.

744, CHESTERTON RURAL DISTRICT COUNCIL.

The Chairman briefly reviewed the work of the Rural District Council during the past year and stated they were developing as rapidly as possible the modern method of street lighting and had formulated a five-year programme. Sewage schemes in various villages had been commenced and that at Cottenham was practically complete. As to a recreation ground, the Rural District Council had now decided to purchase 5 acres of land for this purpose.

745. MILTON SCHOOL.

Mr. L. M. Forbes reported that with 82 pupils the school was now filled to capacity and the necessity for extending the buildings had been notified to the Education Authorities. The appointment of Miss Foulkes as Headmistress had proved a wise choice and their had been a marked improvement in the running of the school over the past year.

746. IMPINGTON VILLAGE COLLEGE.

Mrs. Pearson reported another successful year's work at the College, where some 700 pupils attended. The Juvenile Employment Officer visits the College with a view to finding employment for the pupils of school leaving age, and no less than 34 of the 35 school leavers had been successfully placed in employment. There

was unfortunately a lack of support for the Parent Teachers' Association, and Mrs. Pearson appealed to parents to take a more lively interest in their children's education. The College provided excellent facilities and it was incumbent on parents to give their children the utmost encouragement to take advantage of the opportunities at hand.

OVER 60's CLUB.

Mrs. Pearson reported progress in the Club despite a slight fall in membership to 45, due to the deaths of several members. A Christmas Party and a Summer Outing had been organised and these were very well attended. Members had organised a Bazaar, the proceeds which which amounted to some £48. Mrs. Pearson expressed the gratitude of members for the free use of the Village Hall for their functions.

This concluded the business and the Chairman declared the meeting closed.
