I. COUNCIL BUSINESS

1. 5004 The minutes of the meeting held on 5th January 1982 had been circulated and were confirmed and signed.

2. Matters Arising

- Youth Motorcycle Trials Training Scheme. The Clerk reported (4981) he had spoken to Sgt. Fenn of the City Police and that a meeting to test the noise level had been arranged for Sunday 7th February at 10.30am on site. P.K., B.C.W., A.D.J.B. and R.T.S. agreed to attend.
- 5006 <u>Footbridge Milton By-Pass</u>. H.W.H.E. reported that a gate had (4983)been positioned at the end of Butt Lane and appeared to be shut most of the time.
- 5007 State of Roads. Although he had received no reply to his letter, (4984) the Clerk reported that the cats eyes in High Street/Cambridge Road had been filled in. It was decided to leave the matter in abeyance.
- 5008 Damage to Village Seat. The Clerk having read out a letter from (4985)Cornhill Insurance advising that there is a £5 or 10% excess applicable and that a copy of the account would be required, was instructed to contact Mr. Symonds again.
- 5009 Christmas Carol Service. The Clerk confirmed that he had sent (4986)a £25 donation to the Salvation Army.
- 5010 <u>Tree.</u> M.W. reported that following an inspection with H.W.H.E. (4987) the site was deemed satisfactory. He added that Mrs. Waggett wished to donate the tree. The Clerk was asked to write and thank Mrs. Waggett for her kind donation.
- 3. 5011 Milton Conservation Area. M.W. had prepared a draft notice (4989) to be sent to all owners and occupiers within the designated area informing them of their obligations. G.T. raised the point of the exclusion of Milton House from the area. K.P.H. felt that the Council should ask for reconsideration of the Plan. P.K. proposed, M.W. seconded and all agreed that:
 - (i) the notice together with the schedule from the Cambridge News and a map of the Conservation Area be distributed to all the owners and occupiers in the area presently designated and
 - (ii)a letter be written to the Planning Officer asking for the Conservation Area to be extended to include the south side of Fen Road up to and including Strangeways Cottage and a loop to include a further part of High Street and the cottages in Butt Lane.
- 4. 5012 Local Councils Circular (1/82) / Community Council Literature.

 C.A.L.C. and Community Council literature were circulated and duly noted. The following points were raised:

5015 Milton Plan. A report by the District Councillor and a letter dated 20th January from Mr. Wilson, Planning Officer, S.C.D.C. sent to the Clerk had been circulated. Discussion centred on the issue of community facilities. In view of the fact there is not likely to be a firm undertaking of a reduction of the proposed population growth figure from 3200 to 2000, it was agreed that a reduction in the 12 acres of recreation area would be undesirable since it was felt that these facilities would be necessary after 1991 when further housing development would probably take place. R.D. stressed that the new recreation area should be next to the slip road to avoid housing development right up to the road. It was agreed however that there should be a proportional reduction in the childrens play areas and housing. Councillor J.B. commented that the Council should list the community facilities that it wants. The Council

agreed to support the following policies from the Milton Area District Plan of June 1981:-

Community Services and Facilities: Para 4.1 - Policy 11

Primary Education: Policy 12 (K.P.H.'s suggestion that the Council press for traffic control measures in Butt Lane was strongly opposed by G.P.). The Council to press that Policy 12 be implemented as soon as possible.

Secondary Education: Paras 4.6 and 4.7

Shopping: Policy 13. As agreed with the City Council on September 14th 1981.

<u>Library</u>: Policy 14. K.P.H. commented that a library had been promised before the Structure Plan was drawn up and that the Parish Council has the land for it.

Country Park: Policy 15

<u>Outdoor Recreation</u>: Policy 16

Indoor Recreational Facilities: Para 4.18

Allotments: Policy 17

Public Transport: Policy 18

Cycle and Pedestrian Route: Policy 19

Footpaths: Policy 20

R.T.S. enquired about the 'teardrop area'. K.P.H. commented as that area is partly crossed by the administrative boundary of the City it could end up as white land.
S.B.P. was concerned about the drainage provision and felt this must be properly resolved before any building work commences.

The Clerk was instructed to write, after consultation with the Chairman, to the Planning Officer of S.C.D.C. with the Parish Councils comments.

K.P.H. commented following Mr. Wilson's letter of 23 December 1981 that the corridor proposal would not be substantiated for certification. He suggested however that although he disagrees with the proposal the Council should still fight right through to a Public Inquiry. Councillor J.B. concluded that the Council should be determined that because of the reduction of housing approved it does not prejudice Milton's long term view of its community facilities. If the Council wished to reiterate the corridor plan it must balance what chances there would be for a certified plan. It was agreed not to produce a newsletter because of the

It was agreed not to produce a newsletter because of the expense and lack of time but to report instead to the Annual Parish Meeting.

8. Any Other Business

- 5016 Milton Interchange. B.C.W. reported that clay had been slipping into the drainage ditches from the interchange. G.P. confirmed it was only the top surface on the clay. No action required.
- 5017 <u>Cemetery</u>. Both G.T. and H.W.H.E. brought up the subject of the (4723)cemetery. It was agreed that a Planning Sub Committee meeting be arranged. The Clerk was asked to invite the Rector.
- 5018 Motorcycle Disturbance. H.W.H.E. had received complaints about the noise and speed of the motorcycles in Coles Road. The Clerk was asked to remind P.C. Barringer again about the disturbance caused by these motorcycles.

- 5019 Notice Board. H.W.H.E. enquired about the state of the notice board. The Clerk stated it was in need of repair. Mr. Symonds to be contacted for a repair estimate. The Clerk to report back at the next meeting.
- 5020 <u>Bus Passes</u>. The Clerk read out a letter of thanks from Mr. Watson and also passed on verbal thanks from Mrs. Halls, Mrs. Price and Mrs. Parker.
- 5021 Allotments. A Parishioner had asked if he could have half an allotment. It was agreed that the Clerk find a plot on the recently cultivated area.
- Retirement of Chairman. R.T.S. stated that as he was unable to devote enough time to the office and that as he had been Chairman for 7 years, the Council should be thinking about a successor.

Minutes of the Planning Sub-Committee Meeting held on Friday 19 February 1982 at 7.30pm in Milton Primary School

Present: Mrs. B.C. Waterson (in the Chair), A.D.J. Bull, R. Day, P. Kiddle, S.B. Poulter, H.W.H. Easy, R.T. Summerfield, M. Waggett together with the Rector F. Kilner and the Clerk S.J. Daniels.

Apologies received from K.P. Humphries.

1. The minutes of the meetings held on 23 April 1981 and 23 June 1981 5036were read, confirmed and signed.

2. Matters Arising

- 5037 Anglia Business Computers Winship Industrial Site. The Clerk (5030) read out a letter from S.G. Sillery explaining that the wording used is a standard form which in part is not directly applicable to this permission.
- 3. 5038 Burial Ground Extension. The Rector explained that H.W.H.E. (4723) had contacted him with the concern that, as there was little space left in the present cemetery, urgent thought should be given to extending burial facilities in the village. The expectancy of the cemetery was said to be about 5 to 6 years. The Rector felt that, to many people, the Landbeach Road site was exposed and remote and that a site nearer the village would be more appropriate.

 He suggested, in view of the possible sale of Milton Hall, that land belonging to the E.E.B. adjacent to Church Lane, could be earmarked as burial ground.

 The Parochial Church Council's view that part of the rectory ground be added to the existing churchyard as burial ground was put forward.
