a) Day Centre. J.f.C.f. reported that the day centre at the Community Centre should be in operation by the

The M.C.C. were waiving hire charges and the day centre would be almost self financing.

The kitchen needed upgrading. About £2500 needed to be spent on cooker, catering equipment, deep freeze, chairs, kitchen before the opening. Applications for financial help had been made to Milton Charities, Help the Aged and Age Concern. Social Services had agreed to help

An open meeting was planned for March 8th at which it was hoped to set up a Steering Committee.

Transport would be provided by Edmund House ambulance and social car scheme. It was suggested that Eastern Electricity be approached to sponsor the cooker and under section 137 & 139 of the Local Govt.Act 1972 R.D. proposed J.E.C. seconded and all agreed that/Council approve a grant through payment of bills where possible of up to £1400.

b) Mobile Warden Scheme. This scheme was designed to provide visiting care for the housebound and those who need care in the community. Agreed to set up committee of R.D., D.J.L. and J.F.C.F. to investigate further. It was suggested that Dave Kelleway chair of Teversham P.C. attend May/June meeting to talk about the scheme at Teversham.

H.M.S. felt that support should be given to landowners who were resisting. J.F.C.F. explained that there would not be compulsory purchase. J.E.C. suggested that a joint committee of Milton, Waterbeach Parish Councils and landowners be formed.

It was agreed that representatives attending the Waterbeach P.C. meeting on Tuesday March 2nd would try to arrange a joint meeting with Waterbeach.
