# Matters arising from Minutes

Bus Shelters. The Clerk reported that Milton Men's Institute were agreeable for a bus shelter to be erected on a site within their boundary adjacent to the footpath. It was agreed to submit plans to the County Planning Committee for the erection of a bus shelter on this site and one on a site in the vicinity of Bene't Close. If the erection of a bus shelter on this latter site had the approval of the County Council then it was agreed that the seat, for which approval had already been obtained, be not erected on this site.

#### Ditch - South side of Fen Road

The Clerk read a letter from Chesterton Rural District Council stating that as the Parish Council accepted and retained a rent for Gravel Pit Pasture they should be responsible for cleaning out the ditch fronting this land. After discussion Mr. S. A. Siggs proposed and Mr. J. Bradnam seconded that the Parish Council accept this responsibility, but until such time as the lower length of ditch has been cleaned the cleansing of Gravel Pit ditch would be of no avail. This proposition was carried unanimously.

## Precept - 1953/1954.

The Clerk presented an estimate of expenditure and on the proposition of Mr. D. Pearson, seconded by Mr. S. A. Siggs it was unanimously resolved that a precept in the amount of £40, equivalent to a fourpenny rate, be issued on Chesterton Rural District Council.

30. Recreation Ground 0.S. 149.

Information was received from the County Planning Officer that Mr. A. Winship had submitted an application to develop O.S.P. 149 by extracting gravel. Part of this field had been included in the tentative planning proposals as the proposed village recreation ground, and the Planning Officer was anxious to know whether the Council had changed its views in regard to this site. The Clerk was instructed to inform the County Planning Officer that the view of the Council had not been altered and to confirm that part of O.S.P. 149 was the most suitable site for a recreation ground.

Traffic Sign - Church Lane

Mrs. Pearson drew attention to the danger caused by traffic proceeding to Cambridge from Church Lane and to the need for a "Slow" sign at the junction of Church Lane and Fen Road. The Clerk was instructed to communicate with the County Council.
