II. COUNCIL BUSINESS

1. 4673 The Minutes of the Meeting held on 2nd February 1981 has been circulated and were confirmed and signed.

2. Matters Arising

- 4674 Youth Tutor Milton Youth Club. The Clerk had received a letter from (4261) Mr. Williams of IVC advising the Council that the nightly payment to the Youth Leaders will be increased with effect from 1st April 1981, and in view of this consideration is being given to reducing the number of weeks during which the Youth Club will be run. The sponsorship offered by Mr. Tolliday expires in March 1981 and the Parish Council are responsible for paying for the next two years. The Clerk would acknowledge the letter and request advice as to the course of action being taken by IVC.
- 4675 Tree Damage/Planting. The Clerk had received a letter from the County
 (4520) Council to the effect that the damage originally reported to the trees
 was in fact caused by the S.C.D.C. M.W. confirmed that he had attempted
 to repair the damaged tree and it was hoped that it would survive.

 R.D. announced that there would be a tree planting work party at the
 coming weekend and all help would be appreciated. With reference to minute
 - coming weekend and all help would be appreciated. With reference to minute 4650 R.D. advised the Council that a small variety of trees will be planted rather than 150 poplars as originally agreed.
- 4676 Christmas Carol Service. The Salvation Army confirmed that they would not (4609) be able to attend a carol service on Sunday afternoon since this clashed with the Church carol service. Two other dates were suggested and the Council felt that Friday 18th December would be the most suitable. The Clerk would confirm this by letter.
- 4677 Vehicle Damage, Pond Green. M.W. estimated that 75 posts would be required (4614) to completely fence the green, but the CALC advice was that this may infringe the highways regulations. M.W. suggested therefore that the County Surveyor should be approached with a view to installing 3 or 4 posts to discover what response is forthcoming. Suggestions should also be requested for keeping vehicles off of the green completely.
- 4678 Burial Ground Extension. The Clerk received a letter from Rev. Kilner
 (4635) expressing the decision of the Church Council that the Landbeach Road burial
 ground should be extended in a backwards direction. A.D.J.B. confirmed
 that Gonville & Caius owned the land and extension to the rear as far as
 the ditch which crosses the land would virtually double the present area.
 G.P. felt very strongly that the extension should take place at the existing
 ground rather than a separate site.

It would agreed that the Clerk would approach the Environmental Health Officer, S.C.D.C., to enquire if the ground could be used for such an extension, this course of action having been originally advised by Mr. Martindale.

- 4679 Christmas Tree Lighting. The Clerk received a letter from Eastern
 (4637) Electricity confirming that no further reduction in the account would be possible. Following a proposal by G.F.T., which was seconded by A.D.J.B., it was agreed that the account should be settled.
- 4680 Temporary Library. The Assistant County Librarian had replied to the (4638) Council's request for details of book estimates for the final 12 months for which the British Legion-used Library was open, and the figure was approximately 980 books per month.

Details of the size of the plot of land were not provided but R.T.S. and S.B.P. were given the Council's approval to inspect the site and also to look at a secondhand building measuring 48' x 12' which is available at a negligible cost. A.D.J.B. volunteered to store this building on his farm if necessary.

- 4681 A45 Pedestrian/Cyclist Footbridge. The Clerk received a reply from D. of E. (4639) to the effect that in view of the relatively light use the very high cost of a further bridge could not be justified. It was agreed that the matter would be held pending until the release of the Milton Plan.
- 4682 Fence Repairs. The Clerk received a reply from the Architect at S.C.D.C.

 (4644) confirming that the fencing at the foot of the Cambridge Road council house gardens will be inspected before a decision is made regarding repairs. Progress should be reviewed in one month.
- 4683 Road Markings. It was reported that the incorrect markings had been (4648) removed and the new markings have been put in the correct location.
- Telephone Kiosk Milton By-pass. The Clerk had received yet another (4651) negative reply from the Sales Superintendent who felt that a kiosk could not be justified since it would not pay its way, and could not be considered as a essential service. The Parish Council were totally dissatisfied with this response and it was suggested that the Clerk would write again to the Telephone Manager stating that they are not prepared to let the matter rest, and under no circumstances would there be an agreement to the signposting of the kiosk in the village to attract more vehicles into Milton. It should be pointed out that the matter does not relate to a few extra cars entering the village but an approximate split of 50/50 cars to lorries at present pester A.D.J.B.
- 4685 Untidy Allotment. The Clerk received a reply from Mr. Southall to the (4652) effect that it was his intention to work the holding.
- 4686 <u>Ditch Piping</u>. S.B.P. reported that following site excavation the pipe (4636) configuration was not as originally thought, and the requests for quotations would have to be modified and presented hopefully at the next meeting.
- 4687 A.G.M./Public Meeting. The date originally suggested by the Council proved (4646) to be unsuitable for the Team and the newly agreed date was set at April 13th. The Team did however wish to meet the P.C. beforehand and this will therefore take place on 31st March at 7.30 p.m. in the Village Hall.

It was agreed that a single night advertisement should appear in the Cambridge Evening News and the Clerk would arrange this.

K.P.H. and R.T.S. would prepare a draft newsletter which would be issued after the release of the Draft Plan on 16th March and P.K. agreed to prepare an "impact" front page for the 4-page letter which would be printed. The Chairman instructed the Clerk to invite Councillor Crossman to the public meeting.
