I. COUNCIL BUSINESS

- 1. 236/90 Casual Vacancy. As an election had not been requested by (158/90) ten electors R.T.S. proposed J.F.C.F. seconded and all agreed that the clerk invite Ian May (who had attended many meetings) to fill the vacancy.
- 2. 237/90 Minutes of the meeting of June 4th 1990 having been circulated were confirmed and signed.

3. Matters Arising

238/90 Rail Crossing. The clerk to ask British Rail to reinstate (358/89) a telephone sign by the crossing.

239/90 <u>Village Sign</u>. D.B.W. to see L. Sandford. Progress report (382/89) to follow.

Hedge laving. The British Trust for Conservation Volunteers

who had been unable to come in January were anticipating completing the work in November/December. The cost to be £4.50 per man day. Grants were available from the N.C.C. + aid may be \$7.

241/90 <u>Eastern By-Pass</u>. The clerk to ask for confirmation in (129/90) writing that plans for the Milton Sastern by pass were now shelved.

242/90 <u>Country Park</u>. Mr. Leadley hoped to call a meeting of the (153/90) Working Party in July. J.F.C.F. to clarify an issue raised in his letter to Council.

243/90 Bowling Green. J.E.C. proposed S.J.S. seconded and all (166/90) agreed to accept King's Lynn Landscapes quotation of £499.43 + VAT for re routing the water to two corners of the green.

244/90 Pearson Court. Council supported Mr. Holmes of 1 Pearson Close (170/90) in his request for signs directing visitors to Pearson Court as many callers were mistaking his house for 1 Pearson Court.

245/90 i) Commuted Sum. The auditor pointed out that the interest could be capitalised. If so this money could be used for capital projects only.

J.F.C.F. proposed E.M.C.D. seconded and all agreed that all interest on the capital monies be used for revenue purposes.

- ii) <u>Centre Extension</u>. R.T.S. was waiting to hear from the architect.
- iii) Middleton's Pit. Nothing had yet been planned for this area because of subsidence.

246/90 The Sycamores. Bovis did not wish to open the Sycamores (217/90) road to through traffic as Monsell Youell Homes did not wish to have site traffic using their roads.

4. 247/90 Bund and Open Spaces.

(208/90) (a) A report of the meeting with Mr. Rixon of Bryant Homes was circulated. Bryant intended handing over areas in 1991.

A letter from a resident of Lander Close complaining about the rubble on the new play area and traffic speeding in Froment Way was received. A copy of this letter to be sent to Bryant Homes.

R.D. had met with a landscape gardner to discuss maintenance of the bund and open spaces. His advice was reported to Council.

(214/90) (b) J.F.C.F. proposed R.T.S. seconded and all agreed that Council accept P. Ferguson's quotations for cutting down and spraying the weeds on the shrub borders at The Sycamores recreation ground - £525.00 and The Rowans play area - £60.00.

R.D. was due to meet J. Hellingsworth. J.F.C.F. felt that Council should negotiate with J.H. about the species of trees to replace those lost on the bund.

(c) Bovis Homes suggested a figure of £24780.00 for the commuted sum (min 137/90).

J.E.C. proposed J.F.C.F. seconded and all agreed that Council ask for £35000.00° Copy of letter to J. Hellingsworth.

- 5. 248/90 Grant Aid. It was agreed that the clerk apply for grant aid towards the cost of the cricket square, bowling green and pavilion.
- 6. 249/98 Village Cleaning. R.D. pointed out that although J.F.C.F. had produced a survey of cleaning in other villages

 Council had no legal responsibility to clear litter as yet.

 (There was a responsibility however to maintain the bund etc.)

It was agreed that a sub-committee of J.F.C.F., J.E.C., and S.J.S. be formed to look at village maintenance.

The sub committee would look into all aspects of cleaning/maintenance.

The clerk to ask the Divisional Surveyor to raise the mound in front of the industrial estate to prevent parking; to cut the weeds on the slip road and to ask also what the County Council had in mind for the roundabout.

7. 250/90 Traffic. J.F.C.F. reported that the County Council had agreed to instal rumble strips in Gamlingay.

The clerk to ask the County Council for information about rumble strips; also for the results of the traffic census (conducted July 1989).

J.F.C.F. reported that he had been appointed by S.C.D.C. to the City Council Cycling Working Party which was looking at cycle routes in the city and from the surrounding villages.

8. 251/90 <u>Fidelity Insurance</u>. The auditor had recommended that each councillor and the clerk be insured for £25000 against misappopriation of funds.

The clerk to obtain advice from C.A.L.C.

R.T.S. proposed that the clerk be insured for £250,000 for twelve months subject to costs.

The clerk also to obtain advice from Cornhill about adequate insurance for G. Patten.

Concern was expressed that there was no roll bar on the tractor. Advice to be sought.
