### I. COUNCIL BUSINESS

 218/91 Minutes of the meeting of May 13th 1991 having been circulated were confirmed and signed as a true record.

## 2. Matters Arising

- 219/91 <u>Consent Street</u>. It was noted that the Cambridge Road, (153/91) High Street and Ely Road was due to be made a consent street on July 1st.
- 220/91 <u>I.V.C. Route</u>: J. Vark, Transport Officer had arranged (192/91) to conduct another traffic survey.
- 221/91 Youth Club. Youth liaison panel were due to meet on (193/91). Thursday June 6th.
- 222/91 <u>Joint Meeting with M.C.C.</u> Agreed to hold meeting on (194/91) July 10th at 7.30pm with Finance Committee meeting at 7pm.
- 223/91 New Building. The building was progressing well.
  (195/91) R.J.F. reported that there were two extra items one at minimal cost the other still to be costed.
- 224/91 Tennis Courts. S.B.P. had missed the early works having (197/91) been on holiday but was happy to assist R.D. to monitor progress.
- 225/91 Green Belt Meeting. M.P.C. had not been represented at (198/91) the meeting of May 14th.
- 226/91 Water Main. David Ward was happy to act as M.P.C.'s
  (199/91) land agent. A site meeting to be arranged. According to
  Taylor Vinters the conveyances did not preclude M.P.C.
  from receiving compensation and any legal fees should be
  met by the Water Company.
- 227/91 Country Park. The Working Party were due to meet on (201/91) Tuesday June 4th.

  The warden to attend the July P.C. meeting.
- 228/91 Hospice Donation. A letter of thanks from the Hospice (204/91) for the donation was received.
- 3. 229/91 Traffic. P.C. Barringer attended. Surveys including a recent radar trap had shown no significant speeding problems in the High Street/Cambridge Road.

  After considerable discussion it was agreed to invite the County Council to a site meeting to discuss the following issues:

- Possible speed humps in fen Road, The Rowans, The Sycamores and Humphries Way.
- 2. Speed humps or a pedestrian crossing in Cambridge Road/High Street.
- 3. White "Give Way"/T junction" markings at The Rowans/Cambridge Road junction near Edmund House.
- 4. The effectiveness of diagonal white lines at the northern approach to the village.
- 5. Possible closure of the slip road at the northern approach.
- 6. Weight restriction.
- 7. Signs e.g. "children on holiday."
- 8. Parking bays on the old part of the A10 near the industrial estate.
- 4. 230/91 Christmas Arrangements. The carol singing was usually poorly attended. R.T.S. proposed and R.J.F. seconded that the carol singing round the tree be discontinued for 1991.

  8 votes in favour and 2 against. S.P. to investigate buying the tree from another source.

- 244/91 Use of land for storage of bins for mini skip
  (169/91) business at rear of Cave Industrial Estate refused.
  Contrary to Policy CNF4/2 of Deposit Draft of
  5.C.D.C. Local Plan which does not encourage use that
  would significantly increase traffic in Chesterton Fen
  and Chesterton High Street.
  Approach roads not suitable to cater for number and
  type of vehicle trips especially Fen Road because
  of restricted width and cul-de-sac nature of road.
  Volume of vehicular traffic would have severe
  environmental impact upon residential area.
- 245/91 Two bungalows and garages at r/o 74-78 Coles Road (174/91) approved. Details of materials for external walls and roofs to be approved. Conditions of adequate and permanent space for vehicles to park clear of highway and visibility splays.
