- I. COUNCIL BUSINESS
- 6192 The minutes of the meeting held on 5 November 1984 having been circulated were confirmed and signed.
- 2. Matters Arising
- 6193 Appeal by M.H. Hall. It was noted that Mr. Hall's appeal (5818) against S.C.D.C.'s refusal for use of land for stone crushing had been dismissed by the Inspector for the Secretary of State.
- 6194 <u>Fen Road Crossing</u>. British Rail confirmed that they had
 (6152) distributed 3100 publicity leaflets throughout the local schools and area. It was agreed not to pursue this matter. The clerk would inform B.R. that no stop line had as yet been painted; that the damaged seat had not been repaired and that an engine had been seen to pass through the crossing without activating the lights.
- 6195 Middleton's Pit. The clerk had signed the contract and paid (6155) a deposit of £750. It was expected that contracts would be exchanged during December.
- 6196 <u>Footbridge</u>. All repairs had been completed. (6157)
- 6197 <u>Lights</u>. The trees in Fen Road had been trimmed. The clerk (6159) would thank the residents.
- 6198 Christmas Arrangements. B.C.W. had not been able to contact the (6160) Salvation Army. G.P. reported that the lights were working satisfactorily. Members would meet on Saturday 15 December to erect tree.
- (6162) and the traffic situation seemed to have improved. Copy of a letter from S.C.D.C. to Mr. and Mrs. Rice, Butt Lane confirmed that the C.C. would not provide a parking and turning area at the front of the school. The letter stated the C.C. view that development to the north of Butt Lane should be encouraged and roadways provided before building work on the school extension begins.

 As yet a C.C. reply to the clerk's November letter had not been received.
 - (b) <u>Landscaped Corridor</u>. S.C.D.C. had contacted Mr. Rose to confirm that planning permission would be needed for the mounding adjacent to the A10.
- 6200 <u>Green Belt</u>. The Public Inquiry into the Cambridge Green Belt (6165) Plan would take place at Shire Hall starting at 10.00am on Tuesday January 8th 1985.
- 6201 <u>Hedge Trimming</u>. The work of trimming the hedge at the northern (6168) end of the A10 by-pass was being carried out.
- 6202 <u>Watercourse</u>. <u>Chesterton Fen Road</u>. The complaint about this (6171) watercourse had been referred to A.W.A.

 The access to the footpath was now free although barbed wire

- 6203 Mud on road. K.P.H. had received many complaints about mud (6173) on the road next to the Bene't Farm site. The police had contacted a Mr. Betts on site.
- 6204 Gypsy Site. P.H. reported that the C.C. had decided not to (6174) proceed with the gypsy site on the ground of cost and lack of demand. The C.C. were looking into the possibility of providing a site elsewhere with a skip and tap, for a temporary stay.

 K.P.H. had written to Mrs. Letley of S.C.D.C. to ask what was to become of the Kings Hedges site.
- 6205 The minutes of the Special Meeting of 15 November 1984 having been circulated were duly signed.
- 6206 Milton Development. (a) Recreation Ground. Mr. S. Sillery of S.C.D.C. was welcomed to the meeting. He confirmed that he expects approximately 9 acres of recreation ground to be provided as part of Phase 2 and he would not support any change of policy. Hé could see no objection to the recreation ground being moved into the tree belt if the Parish Council so desired. R.D. felt that such a move could give the village a negotiating point. S.S. still felt that the idea of a levy of £X per house should be pursued. R.D. proposed W.D.B. seconded and all agreed that the Parish Council support the principle of 9 acres of recreation ground or thereabouts. It was agreed that Council's land agent Keith Moore be
 - (b) <u>Drainage</u>. S.S. reported that the 13th Public Drain was being improved with contribution from A.W.A., City Council and S.C.D.C. through the developers.

 The principle now being looked at meant that the 1st, adjacent to the Science Park would be improved and further improvements would be made en route to meet the 13th and Bankers Ditch. This would need to be completed by October 1986 in order to qualify for Trinity College's contribution.

 The 13th was sufficient to cope with 123 new houses.

 The Parish Council would be kept informed of progress in due course. B.C.W. thanked S. Sillery for attending.

invited to the January meeting for an up to date progress report.

4. 6207 Community Centre - Finances. K.P.H. reported that a full discussion took place at the General Purposes Committee. This Committee decided to approach the Finance Committee for a sum out of S.C.D.C. capital funds when full details of the scheme became available. The G.P. Committee appeared to support Milton's efforts to provide community facilities. Copy of a letter sent from the Chairman and Vice Chairman to various S.C.D.C. and C.C. officials and Mr. Pym was circulated. As a result of this letter a meeting was to be arranged in early January at Shire Hall. K.P.H. pointed out that policy 16 of the Milton Plan gave priority to community facilities. B.C.W. thanked R.D. and K.P.H. for presenting the village's A letter had been received informing that the Finance Committee of the Sports Council is to recommend a grant of £30,000 to the project, subject to adequate funds being available. Both R.D. and the clerk had looked at various loan schemes and agreed that the most appropriate would be a 20 year annuity repayment scheme. This would ensure that the cost of repaying the loan would fall upon the new and present residents alike.
