- 1. 95/91 Youth Club. Janet Williams and Sylvia West of I.V.C.,
 Roy and Betty Martin attended.

 S. West was sympathetic to P.C. 's feelings at the sudden closure of the club. The apparent lack of interest at the time made the decision inevitable.

 She would recommend monies to be targeted at Milton. In her opinion local consultation and a local management structure (to liaise directly with I.V.C) was needed.

 It was agreed to set up a youth panel with J.E.C.,
 R. & B. Martin and interested youngsters to discuss the way forward.

- 2. 96/91 The minutes of the meeting of 4th February 1991 having been circulated were confirmed and signed.

3. Matters Arising

- 97/91 Cvcleway. A letter from the County Council pointed out (124/90) that cyclists could now join the cycleway at the Golden Hind roundabout; there were no proposals to increase the island size at Cowley Road but that there were proposals in the Three Year Medium Term Plan subject to funding to construct a bridge over the A45 along the old A10.
- 98/91 <u>Tesco Roundabout</u>. Tesco Stores were looking into the 13/91) possibility of planting the roundabout.
- 99/91 Northern Fringe. A copy of the proposals for the City (17/91) local plan was received. Agreed to make no comment until draft plan is produced. S.J.S. and J.E.C. to attend a meeting on Wednesday March 6th.
- 100/91 Environmental Protection Act. A schedule of S.C.D.C.'s

 (28/91) proposals for litter clearing and street cleaning under
 the terms of the above Act was received.
- 101/91 <u>James Carlton Close.</u> A copy of the conveyance plan (29/91) showing ownership of the land was received.
- 102/91 <u>Landfill Site.</u> J.F.C.F. pointed out that S.C.D.C.'s (64/91) proposal to relocate its offices at Impington Hall Farm could have further traffic implications, for Butt Lane.
- 103/91 <u>Grant Hedge Laying</u>. The County Council had authorised the issue of a cheque.
- 104/91 <u>Footpaths</u>. Negotiations were continuing with County (71/91) Council officers. Landbeach P.C. were now fully informed.
- 105/91 <u>I.V.C. School Bus.</u> J. Vark had replied turning down the (73/91) idea of free transport. Agreed to wait for all other replies.



- 106/91 Finance. Resolution 94/91 no. 1 as recommended by (75/91) the Finance Committee was proposed by R.T.S. and seconded E.M.C.D. Carried 5 votes in favour 3 abstentions. Agreed to ask G. Patten to have Sycamores Recreation Ground fertilised as in 1990.
- 107/91
 Tennis Courts (Planning application 5/0220/91)
 J.F.C.F. proposed and all agreed that Council authorise up to £61,000 in total be allowed for this project (for contingencies).

 Any additional amount to be subject to negotiation.
 R.D. pointed out that a supervising agent would be needed.
- 108./91 Village Cleaning. Mr. Gray had withdrawn his
 (80/91) application. The clerk to ask Mr. Shipp to empty
 Sycamores Recreation bins temporarily (with an increase in wages).

 Main concern was safety of play equipment.
- 109/91 <u>Village Sign.</u> D.B.W. and Len Sandford hoped to proceed (81/91) to next stage within the next week.
- 4. 110/91 Small Hall. Tenders ranging from £89000 £129000 had (77/91) been received. R.T.S. and R.J.F. had met with Neale Associates to look at areas of saving money and were continuing negotiations.

 It was agreed that R.T.S.and R.J.F. could proceed with the lowest tenderer if they were able to negotiate a contract price below £80,000 including contingencies.

 It was noted that planning permission had been granted.
- 5. 111/91 Play Equipment. R.T.S. proposed J.F.C.F. seconded and (70/91) all agreed to accept the City Services quotation for supplying and installing play equipment at the Sycamores Recreation Ground.

 Thanks to J.E.C. and her Committee.
- 6. 112/91 New Pavilion. The pavilion had been handed over.
 (12/91) The committee had agreed that the football club move grounds next season.

J.F.C.F. proposed and all agreed that the Cricket Club should approach M.P.C. for possible financial help if ground expenses prove excessive.

- Agreed to expand the committee to 3 each from the football and cricket clubs and 2 from M.P.C. - J.F.C.F. and D.B.W. - to be reviewed after one year.

Agreed to buy S.B.P. a suitable gift. D.B.W. to follow up.

Agreed to ask Mrs. M. Daniels to cater for the opening ceremony at £2 per head.

7. 113/91 No Smoking. D.B.W. proposed a voluntary request (74/91) e.g. a no smoking reminder at the top of each agenda with a 5 minute break. This to be discussed by new Council.

J.E.C. proposed E.M.C.D. seconded that Council vote on resolution on the agenda:

"No smoking at Council meetings with a 5 minute comfort break in each session."
