COLES ROAD ESTATE EXTENSION - OPEN SPACE.

During preliminary discussions which the County Planning Department had had with Messrs. Gray, Conoley & Co: concerning the development of O.S.P's 129 and 130, the need was stressed to preserve some $1\frac{1}{2}$ acres of public parkland and open space.

The Planning Department were now enquiring whether the Council would be willing to take over and maintain this open space. This would involve the Council in the expense of rough mowing the grassed area two or three times a year. It was intended that the open space would be available to all the inhabitants of the village and not just the people living on the estate. After careful consideration the Council declined to accept responsibility for maintaining the open space as this adjoined the area earmarked for the recreation ground, the maintenance of which would stretch their resources to the limit.
