J.F.C.F. proposed and E.M.C.D. seconded under the "Public Bodies (Admission to Meetings) Act 1960 "that the press and public be excluded from discussion regarding the pharmacy as there could be disclosure of a personal and confidential nature. There were 7 votes in favour and 3 abstentions. R.T.S. proposed R.D. seconded and all agreed that M.L. stay. Following considerable discussion J.F.C.F. proposed E.M.C.D. seconded and all agreed the following: "the Parish Council considers the content of the letters should be taken into account and believes that they accord with the views expressed at the subsequent public meeting of October 24th 1988."
