#### 3. Proposal for Pond Green

(149/98)

Ian Cowley attended to present his "Millennium" proposal for Pond Green. He proposed that the Green be extended to make a focal point of the historic centre of the village. By introducing 'Give Way' signs at the junctions Council could also effectively slow down traffic. Grants were available from the Millennium Commission for Millennium projects such as this.

JEC proposed and RD seconded that MPC ask the Highway Authority if this scheme was feasible. Agreed.

# 180/98 **8. Fidelity Insurance**

#### 183/98 11. Purchase of Daffodil Bulbs

RD proposed HMS seconded and all agreed to spend up to £70 on daffodil bulbs in 1998.

### 184/98 12. Sheltered Housing

(125/98) The Sports Council had withdrawn its objection provided that some of the money acquired for the sale of the site go towards formal recreation ground equivalent to the amount of land lost. CHS and SCDC were dealing with the matter.

MPC had not yet been informed as to whether the County Archaeologist had completed his work.

In response to a letter from SCDC PKO proposed JS seconded and all agreed that the scheme be named Barnabas Court.



# 185/98 13. Concessionary Bus Pass Scheme

The County Council had agreed to provide bus passes at £5.50 each for those in special need for example on income support, registered blind etc. SCDC had increased their subsidy so that all other pensioners would pay £16 per pass.

HMS proposed and RJF seconded that MPC refund £5.50 per bus pass for all.

JEC proposed an amendment and RD seconded that MPC refund £10 per £16 pass and refund in full for those with special needs (names not to be published in minutes).

There were two in favour of the amendment, ten against and two abstentions. The substantive motion was then carried thirteen votes in favour with one abstention.

### 186/98 14. Review of Salaries

RTS proposed that all employees be put on the new Local Government scale. All agreed.

Village Cleaning.

RTS proposed IFM seconded and all agreed that R Adams be put on Scale 1 spinal point 6 (equals £4.30 per hour 1997 rate).

**Community Care** 

RTS proposed IFM seconded and all agreed that the warden be put on Scale 2 spinal point 12 (equals £5.26 per hour 1997 rate).

Clerk

RTS proposed IFM seconded and all agreed that the clerk be put on Scale 4 spinal point 21 (equals £7.05 per hour 1997 rate - the maximum spinal point had been increased from 19 to 21 in order to acknowledge and properly remunerate the additional duties and responsibilities falling on clerks).

All these increases to take effect from 1 April 1998 as soon as the new pay scales are published.

JEC was pleased to see the cycle bridge over the A14 at Milton in the TPP. bid

The Conservation Area Appraisal Consultation Draft had been published, comments to be made to the clerk by end of April for submission to SCDC.

The "Dog Fouling" bye-law was now in force. It was agreed that the Play/Maintenance Committee should meet the Dog Warden and be given the authority to have the appropriate signs erected.

# 9. Land at War Memorial (confidential and not open to the public - see min 181/98)

The District Valuer (DV) had been instructed by the Treasury Solicitor to invite all interested parties to submit unconditional sealed bids for the land. The DV had agreed to put back the date for receiving these bids to April 16th. It was agreed that the clerk and chairman sign the Statutory Declarations drawn up by the solicitor detailing the seats, war memorial, footpath and maintenance of the site.

RTS had ascertained from the Planners that the land is designated as "open space".

JS proposed that Council bid £250 for the land - not seconded.

RJF proposed that Council bid £300, seconded RD. Carried by 13 votes in favour one abstention.
