I. COUNCIL

- 1. 230/94 <u>Detached Youth Worker</u>. D.T.W. introduced Ken Carstairs detached youth worker.
- 2. 231/94 <u>D. Day Remembrance</u>. D.T.W. had attended a ceremony to plant trees at the Country Park. A memorial stone was due to be laid in 1995.
- 3. 232/94 Angliah Water Sewage Works. John Barker of Anglian (187/94) Water and Mr. Hefernan an E.H.O. of S.C.D.C. attended.

Mr. Barker gave a detailed explanation of the process to treat sewage. It had taken A.W.A. about three months to discover the cause of the smells. Four years of drought followed by heavy rainfall helped cause smells. Active steps had been taken to prevent recurrence. The new Bio Active Plant should be "up and running" within a week.

In response to a question J. Barker explained that lorries emptied waste from cess pits into tanks but did not wash out the lorries on site. They were looking at ways of ensuring the discharge does not smell. The level of complaints had decreased since February.

M.P.C. would monitor the situation. Any complaints would be followed up by A.W.A. Information such as wind direction and dates of smells would be useful.

D.T.W. thanked J. Barker for the presentation.

II. PLANNING

259/94 Minutes of the meeting of 9 May 1994 having been circulated were confirmed and signed.

2. Matters Arising.

260/94 (168/94) Rowing Lake. Conditions to be imposed by S.C.D.C. were received. The clerk had protested that less than two weeks had been allowed for Council's comments.

There was nothing in the application which controlled access from Fen Road except during construction.

Landscaping scheme. It was felt that time limit for replanting dead trees should be extended to 8-10 years.

The Deed of Agreement between the Rowing Trust and S.C.D.C. needed clarification in the section "Public Access".



261/94 (115/94) Appeal by Mr. Sutcliffe and Mr. Nuttall. Noted that the appeal against S.C.D.C.'s refusal to allow a golf practice centre including club house, par 3 golf course and 18 driving bays on land off Ely Road had been turned down. Messrs. Sutcliffe and Nuttall intended to proceed with a reduced scheme (no floodlighting).

262/94 (175/94) 5 Butt Lane. Noted that planning permission was not required for this extension.
