# Minutes of the Meetings of Milton Parish Council held on Monday 6th July 1987 at 7.30pm in the Community Centre.

#### I. COUNCIL BUSINESS

1. 7180 Minutes of the meeting of 1st June 1987 having been circulated were confirmed and signed.

#### 2. Matters Arising

- 7181 <u>Footpath Repairs</u>. The Divisional Surveyor had arranged for (7055)patching works to be carried out in Pryor Close and outside 8-10 Cambridge Road.
- 7182 A45 Footbridge. M.P.C. would not be allowed to take part in (7121) the transportation study. The Transportation Department of the County Council would keep M.P.C. informed of the results of the study in early 1988.
- 7183 Industrial Site. The Trees and Woodlands Officer of the S.C.D.C. (7124) felt that indigenous trees were preferable to cupressus at the approach to the village.

  E.M.C.D. proposed that Council should now plan for effective evergreen screening in front of the industrial site. J.F.C.F. seconded. There were 3 votes in favour, 3 against and 3 abstentions.

  The motion was therefore not carried.
- 7184 <u>Postal Service</u>. The Post Office having tested the postmen's (7134)duties were in the process of implementing a revision of duties.
- 7185 <u>Seat.</u> B.L. Tyrrell had agreed to repair the seat in Bene't Close. (7148)
- 7186 Gypsy Site. A copy of the regulations had been received and (7149)circulated.

  It was agreed to ask for the site to be tidied. The County Council would be reminded of the need for proper fencing.
- 7187 Structure Plan. Copies of Council's comments had been sent (7152) to the County Council and were put on deposit with the plan.
- 7188 <u>I.V.C. Governors</u>. D.B.W. reported that from 1989 the Parish (7153)Councils in Impington's catchment area would be allowed to nominate two representatives between them instead of seven as at present.
- 7189 Overgrown Hedges. It was noted that the hedges had been trimmed. (7156)R.T.S. felt that rubbish had accumulated in the garden of one house and also that the hedge could be trimmed back even more. The clerk would inform the relevant person.
- 7190 Weedspraying. It was noted that the weedkiller Herbazin had (7157)been used for 7 years with no complaints about ill-effects.

  The County Council did not feel it necessary to cease spraying

during school holidays

- 7191 <u>Crash Barriers</u>. It was noted that crash barrier installation (7158) between Girton and Nine Mile Hill on the A45 would begin in the Autumn.
- 7192 Land adjacent to the Slip Road. A letter was received suggesting (7160) Council approach the owners of the land with a view to purchase. It was agreed to wait until after confirmation of the Green Belt before sending any letter.
- 7193 <u>Trees.</u> R.D. would use the County Council trees mostly as (7162) replacements.

  L.M.L. on behalf of Council thanked R.D. for his continuing work in tree planting.

  The clerk was awaiting a reply from S.C.D.C. about concerns over possible loss of trees along the old drive to Rectory Farm.
- 7194 Village Sign. The clerk would find out the latest position.
- 3. 7195 Car Park. It was proposed R.D. seconded J.H. and agreed by all that £383.00 plus £57.45 VAT be paid to Lavender and Bateman Ltd for lining the car park.
- 4. 7196 Request from Bottisham V.C. Swimming Pool Association.
  R.T.S. proposed D.B.W. seconded and all agreed that Council reject the request for a donation towards an extension to Bottisham Swimming Pool.
- 5. 7197 Traffic Policy. Various complaints about traffic had been received including concern expressed through the governors of Milton School about the volume of traffic especially in Butt Lane.

  It was agreed:
  - 1. To request Costain Ltd to refrain from using Butt Lane between 8.30 and 9.00am and 3.00 and 4.00pm with heavy construction traffic; to request also that a footpath connection be built from Gunnell Close to the school earlier rather than later.
  - earlier rather than later.

    2. To ask Eastern Electricity, R.M.C. Ltd., and Dickersons to use the by-pass rather than High Street/Cambridge Road.
  - 3. To ask the Chief Constable if a complete traffic census could be taken using a "marksman." Having received the results Council could then decide what course of action if any to take about speeding and H.G.V.'s through the village.
  - 4. To request pedestrian phased lights at the Science Park traffic lights.
  - 5. To ask for better street lighting in Butt Lane beyond Lyndhurst Close and remind Mr. Belfield of the Dept of Transport of the need for lighting at the Landbeach Road junction.

It was noted that the school sign was obscured. The resident would be asked to trim the hedge.

6. 7198 Grass Cutting - Willow Crescent. A request from a resident to include a piece of land in Willow Crescent on the grass cutting rota had been received. As Mr. Hall felt unable to cut the grass and as the land was in front of houses

it was proposed J.H. seconded R.D. and agreed by all to refuse the request.

- 7200 Motor Cycle Dangers. It was reported that motor cyclists were endangering animals and children at "Dickerson's" Pit. All users, however, were trespassing. It was hoped that these problems would disappear after the opening of the Country Park.
- 7201 <u>Community Centre</u>. J.E.C. wondered if a "Community Centre" sign could be erected at the entrance to the recreation ground the request to be passed to M.C.C. Executive Committee.
- 7202 Mobile Library. The new times for the mobile library were noted Monday Coles Road 2.10 3.00

- 7203 Audit of Accounts. Notice of audit of accounts was received. Documents to be made available on October 5th, the clerk to see the auditor on November 6th 1987.
- 7204 Footpaths. Following the 1981 Wildlife and Countryside Act the County Council had made an order modifying the Definitive Map and Statement of Public Rights of Way. This order concerned paths and ways which were added or amended in 1972 i.e. Mere Way and from Chesterton Fen Road to the haling way.
- 7205 Telephone Kiosks. It was noted that British Telecom intended replacing the existing telephone kiosks with booths of a new American design, unless there was good reason for retaining the existing kiosks.

#### 3. Matters Arising

- 7208 Appeal by R. Bousted 5/0223/87. It was noted that (7062)R. Bousted had appealed against the refusal of planning permission for one dwelling on land at Ely Road. Council's (7142) comments had already been sent.
  - Appeal by Perrys 5/2414/86. Perrys had appealed against (7070)S.C.D.C.'s decision to refuse permission for change of use to office premises at 6a High Street. The clerk had written to the Department of Environment repeating Council's original comments.
  - 7210 Landscaped Bund. Bryant Homes had sent details of the grassed play areas and landscaped bund.
  - 4. 7211 Meeting with K. Moore. A report of the meeting with K. Moore had been circulated. He had written to Tesco about the loss of 1 acre, the siting of the recreation ground partly into the tree belt, the position of the 13th Public Drain and the exact amount of work to be done on the recreation ground before hand-over. As a result of the Tesco appeal decision the library service had asked if any of the £200,000 promised could be used towards a library. Council totally opposed this idea. It was agreed to ask the library service which site would be most suitable for a library -Coles Road next to the butcher's shop, next to Tesco, the school or the Community Centre.
