MATTERS ARISING FROM MINUTES.

159. Proposed New Primary School - The Clerk was instructed to write to the County Planning Officer pointing out that a special meeting had been called on the 17th October 1955 to consider four different layouts on O.S. 139, the field behind the oldest Council houses, when it was strongly recommended that the layout comprising an area of .92 acres was eminently suitable for the new school. Information was now forthcoming that negotiations were taking place for the purchase of a site in Butt Lane, O.S. Nos. 69 and 69A, Mr. F. Garner's garden, for the school and it was regretted very much that this drastic alteration in plans should be made by the County Council in view of the recommendation already referred to.

160. PUBLIC LOCAL INQUIRY - UNITED TAXIS LIMITED.

No action was taken with regard to an Inquiry into an appeal by United Taxis Limited against the refusal of the County Council to permit the use of land and erection of buildings on the south-east side of Cambridge Road to the north of the City Council sewage disposal works for the repair and servicing of taxicabs and light engineering work.

162. STREET LIGHTING.

THE GREEN.

Information was received from the County Planning Officer that O.S.P. 98, Junction of High Street and Church Lane, was allocated in the Development Plan partly for the re-alignment of the trunk road and partly for Public Open Space. The purpose in allocating the land for open space was to provide a village green and also to serve as a site to replace the War Memorial and for a bus shelter. The owner had been refused permission to develop the area for residential purposes and consequently had served a purchase notice on the Rural District Council. The total claim on the whole of O.S.P. 98 amounted to £545, and the cost of acquiring the area for
