Minutes of the Meetings of Milton Parish Council held on Monday
November 1983 at 7.30pm in Milton Primary School.

Present: Mrs. B.C. Waterson (in the chair), W.D. Booth, A.D.J. Bull, R. Day, H.W.H. Easy, P. Harrold, K.P. Humphries, G. Patten, Mrs. J. Westwood and the clerk S.J. Daniels,

Apologies for absence received from: Mrs. G. Tonks and Cllr. J. Brackenbury.

I. COUNCIL BUSINESS

- 1. 5758 Finances of V.H.R.G.M.C. The chairman welcomed to the (5720) meeting Mr. R. Norman and Mr. D. Jones chairman and treasurer respectively of the above committee. D.J. circulated copies of his committee's accounts. It was noted that during 1982/83 there was a deficit of approx. £1460 in running costs of the village hall which was made good by the income from dances etc. During the present year there had been a drop of about £1000 from entertainments although the outlook now seemed healthier. It was felt that the sub committee (the committee responsible for putting on dances and other functions) could continue to stage dances but other money raising events would be most unlikely since this committee was operating with no secretary or chairman and only 5 members. R.N. explained that his sub committee felt unwilling to be committed to make the hall financially viable but would rather raise money for extra specific items. He therefore requested the parish council to consider granting an extra £1000 in addition to its usual grant for 1985/85 in order to balance expenses and income thus spreading the costs of the hall throughout the village. G.P. supported this view although H.W.H.E. felt it would make more sense for the clubs, societies etc., to pay increased rents for use of the hall. G.P. thanked Mr. Jones on behalf of the council for the time and effort put into presenting the accounts. B.C.W. thanked Mr. Norman and his committee for their hard work and stressed that if extra help was needed the M.P.C. would be willing to try to give assistance. Mr. Norman's comments would be considered at the December meeting when council would be precepting for 1984/85.
- 5759 The minutes of the meeting held on 3 October 1983 having been circulated were confirmed and signed.

3. Matters Arising

- 5760 <u>Footbridge Butt Lane</u>. Notice had been received that the (5663) "prohibition of driving of motor cycles order" for the footbridge would be publicised on the 17 November. The closing date for receipt of objections would be 12 December.
- 5761 Village Sign. Mr. Sandford had seen the Holders and
 (5721) would obtain plywood for Mrs. Holder to paint as a trial
 run. He felt that lead should be used at the top and
 bottom for preservation of the sign. The post, probably
 asquare oak, would need to be sunk five feet into the ground.
 B.C.W. was awaiting a further report from Mr. Sandford.
- 5762 <u>Tree Planting</u>. R.D. had telephoned Mr. Kisby on 18 October. (5726) Mr. Kisby confirmed that trees could be planted on the

Waterbeach Road verge in front of the meadow but not south of the Milton sign.

- 5763 Traffic Matters. Confirmation of minute 5727 had been received. (5727) R.D. was still uncertain as to the type of trees allowed at the bottom of the slip road. The clerk would arrange another meeting with Mr. Cornwell of the Department of Transportation. R.D. and G.P. would attend.
- 5764 Milton Plan. A copy of Mr. Miles' notes of the meeting held (5732) on 30 September was circulated. Another meeting had been arranged for 11 November to discuss plans for housing. B.C.W., A.D.J.B. and H.W.H.E. would attend, as G.P. was unavailable.

 Concern was expressed about the tree belt and G.P. felt that M.P.C. should state that it expected a density similar to that at Peterborough.
- Green Belt. On J.B.'s advice the clerk had requested a public (5734) meeting in Milton, which was turned down. J.B. had indicated that he would be willing to pursue the matter further. It was decided however not to press for one. B.C.W. hoped that members would attend the important meeting in Fisher Hall of November 8th. W.D.B. reported on the meeting that he and P.H. attended at I.V.C. The sewage works could not be included in the Green Belt. The County Council would not recommend the teardrop site for Green Belt since this land was compromised by the Science Park and the sewage works. S.C.D.C. however were supporting Milton re: the teardrop site. If St. John's were successful in their proposals to develop the site S.C.D.C. would insist on appropriate landscaping. The C.C. would invite the Countryside Commission, S.C.D.C., City Council and M.P.C. to a joint meeting to discuss the Country Park. At present the C.C. had no money available to purchase the necessary land at Milton Pits, over the next three years. It was agreed that the clerk write to the County Council with a copy to S.C.D.C. noting that a public meeting had been refused Milton and that the village fully supported M.P.C. in its attempt to include the teardrop site in the Green Belt as stated in the Structure Plan in order to prevent coalescence with the city. There was already allocated the acreage of industrial development as agreed in the local plan. The offer of a meeting to discuss the implementation of the Country Park as proposed in the Structure Plan was welcomed.
- 5766 <u>Cambridge Community Action Project</u>. Camcap had indicated their (5735) unwillingness to take on any outdoor projects at the present time.
- 5767 Casual Vacancy. As twelve members of the electorate had (5736) requested an election nominations for the vacancy had been sought. The clerk was waiting to hear the outcome from S.C.D.C. If a poll was necessary it would take place on 1 December.
- 4. 5768 <u>Cemetery</u>. The conveyance had been signed by the clerk and (5722)chairman and the fees of £1882.44 paid. Due to an error another conveyance had to be executed and a further £100 paid to make up the balance due:

- 6. 5770 Christmas Tree. R.D. proposed, G.P. seconded that the offer of a Douglas fir be accepted and that it be planted on Pond Green.

 H.W.H.E. proposed an amendment, not seconded, that the tree be planted on the piece of land near the recreation ground car park.

 For the proposal 6 voted in favour, 1 against with 1 abstention. The clerk would thank Mr. Cox for his gift and offer R.D. and G.P.'s help if needed.

- 5778 Lowering of Kerbs. The clerk would write to the Highways
 Department to request a lowering of the kerbs near 14 and 18
 High Street and at the Coles Road, Fen Road junction in order
 to improve conditions for wheelchair users.
- 5779 <u>Allotments Pump</u>. A request for another pump on the allotment site was refused.
- 5780 Tree Bene't Close. The clerk had received a request to have the dead tree situated near 1 Bene't Close cut down because it was dangerous. K.P.H. would contact S.C.D.C.
