I. COUNCIL BUSINESS

1. 1/90 Road Strategy. This item was taken first. D.B.W. had (459/89) produced a draft of observations on the County Council's road proposals.

Considerable discussion ensued during which the draft was amended. A further draft was to be produced prior to the meeting of January 22nd.

Conclusions

- J.F.C.F. felt that if one of the alternative routes suggested by Council were not supported by the County Council then M.P.C. should object at least to the section of route 1 from the A10 to the A45 (the eastern bypass).
- 1. R.T.S. proposed and R.D. seconded that Council object to the whole of route 1 including the southern route since it would cause significant environmental damage also to Chesterton, Fen Ditton and the Riverside area of Cambridge. Carried by 8 votes to 1.
- 2. E.M.C.D. proposed J.F.C.F. seconded and all agreed that Council should press for the development of a Cambridge eastern by pass from the A1D to cross the river Cambetween Horningsea and Clayhythe, to skirt Horningsea to the east, to link with route 2 at the A45 and to join up with route 3 and 3a thus forming a complete eastern by pass of Cambridge.
- 3. A route along Akeman Street under the A45 and into the Science Park was suggested.

Council gave D.B.W. a unanimous vote of thanks for the hard work put into the draft.

2. 2/90 Minutes of the meeting of 4 December 1989 having been circulated were confirmed and signed.

3. Matters Arising

3/90 Open Spaces: following Counsel's opinion the solicitor's (454/89) advice was to proceed with the hand over of the £135,000. The money was now in the hands of the solicitor who was awaiting the title deeds of the land.
