Minutes of the Meetings of Milton Parish Council held on Monday 8 August 1983 at 7.30pm in Milton Primary School.

I. COUNCIL BUSINESS

 5651 The minutes of the meeting held on 4 July 1983 having been circulated were confirmed and signed.

2. Matters Arising

- 5652 <u>Cemetery</u>. A letter had been received from the Church Council (5441) requesting a meeting to discuss future administration of the cemetery. It was agreed to put it on the agenda for the September meeting.
- 5653 <u>Ditch Old School Lane</u>. The Divisional Surveyor had found (5567) that the headwalls on this culvert were safe. He agreed that the ditch needed clearing out and would make enquiries as to whose responsibility this was.
- 5654 <u>Village Sign</u>. As Mr. Holder would be away in September it was (5625) agreed to invite him to the October meeting.
- 5655 Level Crossing. As complaints were still being received the (5627) clerk would ascertain from British Rail the expected date of the repair work.
- 5656 <u>Traffic</u>. It was decided to discuss this matter at the (5631) September meeting.
- 5657 Newsletter. Many favourable comments had been made about the (5632) newsletter. J.B. was pleased to have made the contacts that came his way as a result of it.
- 5658 Date for meeting with the Village Hall Committee. As the (5636) 13 September was unacceptable the 21 and 28 September were put forward as alternatives. Mr. Norman would confirm one of these.
- 5659 <u>Community Adviser</u>. A further letter from S.C.D.C. had been (5638) received asking for a nomination. The clerk would reply that a representative would not be sent for 1983/84.
- 3. 5660 Milton District Plan. D.V.M. and R.D. in association with Keith Miles of S.C.D.C. had come up with ideas for the siting of the recreation ground. Three viable alternatives were put forward by D.V.M.

 On Wednesday 10 August B.C.W., K.P.H. and D.V.M. would be meeting the planners and developers to discuss the issues involved. They would press for the recreation ground to be sited adjacent to the slip road as a first choice. There would be much hard bargaining but the council members would be looking for the best possible deal with the developers. J.B. expressed his thanks to D.V.M. and R.D. for the hard work that they had done.

 Green Belt. J.B. had received letters from the Parish Council and parishioners. He was prepared to support Milton. The County had not yet decided what to do with

the 'tear-drop' site. He would put Milton's view at County Council Development meetings.

Country Park. J.B. had not heard that the future of the Country Park could be at risk. He would look into the matter. He had received a letter from Mr. Sillery stating that the 'hair-brained' scheme for the Gypsy Site at Milton Pits 'can be forgotten.'

J.B. would keep an eye on the Gypsy Site near Mere Way.

- 4. 5661 <u>C.A.L.C. Bulletin 4/83</u>. This was duly received and noted together with a letter from B.B.C. Radio Cambridgeshire asking for a village correspondent. The National Playing Fields Association would be holding a conference in November. B.C.W. expressed interest and wondered if the Parish Council should send a delegate.
- 5. 5662 <u>Bills for Payment</u>. It was proposed G.T. seconded D.V.M. and agreed by all that the following bills be paid.

6. Any Other Business

- Milton By-Pass Footbridge. It was noted that the County Council were proposing to implement an order to prohibit motorcycling on the bridge and approach ramps. The Parish Council expressed agreement with this.
- 5664 <u>Village Hall Licence</u>. Mr. R. Norman and R. Dowsing had applied for the transfer of the Village Hall licence.
- Noise Disturbance. K.P.H. had received a letter from a resident of Old School Lane complaining about the noise caused by fishermen between 11.30pm and 7am. K.P.H. was contacting Environmental Health and the clerk would do likewise and also contact Histon and District Angling Society.
- 5666 <u>Damaged Bollard Pond Green</u>. The clerk would ask Derek Haird if the damaged bollard could either be repaired or replaced.

II. PLANNING BUSINESS

5667 The minutes of the meeting held on 4 July having been circulated were confirmed and signed.

Matters Arising.

- Centre Building Science Park. It was noted that Mr. D.A. (5445) Cowper, solicitor was applying for a provisional grant of an on licence on behalf of Trinity College.
- Take Away 59 Cambridge Road. The S.C.D.C. Planning Committee (5643) had raised no objection to the flue subject to it being painted to reduce its visual impact. This flue had been designed in consultation with the Environmental Services Officer.
- Ash Tree, Queen Anne Lodge. A copy of a letter from 5.C.D.C. (5644) to Mr. Holder stated that the trees officer would have no objection to the removal of the ash tree which was infected with honey fungus.
- 5671 Cul-De-Sac Development, Butt Lane. M.P.C. had objected to Mr. Zdrodowski's application 5/0997/83 on the grounds of Section 2.06 of the Milton Plan. K.P.H. explained that Section 2.06 did not apply to this part of Butt Lane since it did not fall within the proposed housing areas. He had therefore lodged an objection on behalf of the Parish Council suggesting that all such potential development areas in Butt Lane should be included under the umbrella of 2.06. Having declared an interest K.P.H. withdrew from the discussion. D.V.M. proposed, G.T. seconded that the Parish Council uphold the objection lodged by K.P.H.

New Applications

(a) 5672 S/1179/83

Noblelight, 121-5 Cambridge Road - erection of single storey industrial/science building at Science Park. It was queried whether this came under the Science Park concept of research rather than production

as stated on the application. P.C. Cundick, 24 Station Road, Waterbeach demolition of cottage and erection of house at 44 Fen Road. Very suitable replacement.

D.E.W. Freeman, 4 Pryor Close - extension and improvements - no comment. (d) 5675 S/1236/83 Sinclair Research Ltd, Milton Hall -

- alterations and minor extensions to form research labs, offices and flat. M.P.C. objected to:
- 1. The cutting down of mature trees.
- 2. The erection of the colonnade which would spoil the front aspect of the Hall.
- 3. The hotch-potch of architectural styles.
- 4. The re-opening of the entrance in Church Lane.

It was agreed to ask what had happened to the proposed removal of the fence so as to open up the view of the Hall.

(e) 5676 S/1237/83

Sinclair Research Ltd - conversion of top floor to flat and various alterations. It was noted that the existing steps were in proportion with the Tuscan doorway and that the introduction of new front steps would completely ruin the original concept.

The clerk read a letter which stated that the Trees Officer had no objection to the removal of scrub up to $2\frac{1}{2}$ inches stem diameter at chest height and the removal of the mulberry and paulownia at the rear of the Hall. The Parish Council would be kept informed of any further developments regarding the landscaping aspect.

(f) 5677 S/0554/83 Trinity College, Centre Building, Science Park - For Information Only - Access realigned and extra car park.

No development to be started until full details have been submitted to and approved by the Local Planning Authority. Subject also to certain conditions in the interest of highway safety.
