Matters Arising from previous meetings:-

2957 Removed Elm Tree - Coles Road/A10 Corner - SCDC asked if we wished to contribute towards the cost of a replacement - defer decision until next meeting - clerk to provide details of suitable trees for planting.

2958 <u>Street Lighting Reductions</u> - amendments proposed by the Council were accepted by the County Surveyor.

2959 Refuse Circular - has been circulated by arrangement with the Scout Group Leader (2938) Mr. Tiplady. Proposed GEP and seconded by HWHE that a letter of thanks should be sent.

2960 Middleton's Pit - SCDC Planning Officer felt that there would be no problem of (2940) 'overfilling' in view of the conditions imposed. The Chairman thanked SBP for his detailed report on the situation which concluded that there is still plenty of filling required.

2961 Shirley Close Estate - rubbish dumping - no reply from SCDC. Proposed by HWHE (2941) that Moss should be asked if permission has been given to any residents for rubbish tipping on the site.

2962 Boulton & Paul - outside storage of materials - No reply from SCDC. (2942)

2963 <u>Dunn bequest seats</u> - VHMC happy for the Council to place the 2 seats by the War (2943) <u>Memorial</u>. Repairs will be necessary.

2964 Offer of Trees by Co. Land Agent - No reply. (2945B)

2965 Review of Insurance - Amendments were acceptable and a quotation for capital (2946) benefits costing a premium of 65p. for each of the 9 council members + clerk and secretary was selected.

2966 (2944) Changing Rooms - PK provided estimate of completion cost as £7,200-£7,400. The Chairman of the Parish Council had instructed the Secretary of the Working Party Mr. M. Gray to make the Grant Applications immediately. There were insufficient funds available to pay contractors bills to hand. The Building Inspector was reluctant to provide a certificate of completion until 3 outstanding items were given attention (1) painting/finishing (2) making good holes following plumbing installation (3) provision of a platform beneath access doors because of 12/18" drop.

KPH said that after his negotiations that day he now had definite assurance from the District Engineer that the remainder of the District Council grant (about £900) would be paid on issue of a completion certificate (receipted bills unnecessary) and further that the Engineer had agreed to pay over £250 of this money to the Changing Rooms a/c within the next few days to settle the Working Party's two outstanding bills. In all, he said, from both District & County grants a sum of £2,201 was still to come and it was obtainable on completion.

2966 contd.

The Chairman was perturbed that the grants had not been applied for after the last meeting since the point had been minuted. HWHE suggested we pay over £1200.00 to the Changing Rooms A/C as a loan - this was put to a vote 5 in favour 1 against. At Mr. Waggett's suggestion a time limit of 6 months was AGREED. Also AGREED outstanding building costs (if any) still not covered by receipt of the grant moneys be deducted from the £1200 before repayment. The loan would enable the Working Party to provide working capital until the final figures are established.

- 2967 Gray Conoley Land site examination meeting Tuesday 22nd June 7.30 p.m. Also to (2954) inspect Dunn seats and decide location for them and new notice board.
- 2968 VHMC Accounts were received. The Clerk (KPH) had passed The Councils thanks to the VHMC Treasurer.
- 2969 Grant to VHMC GP proposed a figure of £700 this was seconded by PK and agreed. (2409)
- 2970 Investment of Council's balances deferred until next meeting. (2918)
- 2971 Revised Lighting Agreement with Eastern Electricity for the 2 bus shelters was signed by the Chairman.
- 2972 <u>Bills for Payment Proposed by PK and seconded SP, following items agreed for payment.</u>
