Noted that Abatement Notices in respect of a nuisance had been served on the travellers and S.C.D.C. were (130/95)currently pursuing the owners to clear the land. The Environmental Services & Health Committee were discussing the issue and the possibility of compulsory purchase. R.T.S. had been pursuing this matter with the E.H.O. A full written response would be forthcoming from the E.H.O. Agreed to send a copy to Jim Paice M.P. S.C.D.C. were looking at the possibility of using part of this land as a "swap" for the sheltered housing site. It was agreed to invite M. Harris and Mrs. Wilson to the June meeting to discuss both their short term and long term measures to prevent the use of the land by travellers. Noted that the fence by the A14 adjacent to the old A10 was broken. J.E.C. was pursuing this with the County Council. 179/95 Sheltered Housing. The clerk to ask for a response from S.C.D.C. by June 5th. (133/95)Farm College. Mr. Whittington, Principal promised to keep Council 180/95 (135/95)informed of any progress. 181/95 Annual Parish Meeting. Traffic Lights: J.E.C. to pursue issues raised about the traffic lights (164/95)at the A10/A14 junction. Bus Stop opposite Tesco: To be discussed by Maintenance Committee. Thanks to H.M.S. for cleaning "lard" from the bus shelters. 182/95 11. Computer. J. Sandford declared an interest and took no part (138/95)in the discussion. The committee had recommended purchasing a computer from Branford Computing at £975 + VAT - £1145.63 and a laser printer from World of Computers at £383 + VAT - £450.03. J.E.C. proposed I.F.M. seconded and all agreed to accept the committee's recommendations. 183/95 12 M.C.C. Constitution. Agreed to give all members of MPC and MCC (127/95)until June 5th to comment on the draft Constitution. ii. Agreed to suggest 27th September as the date for a joint meeting. iii. Accounts for 1994/5 were received. 184/95 13. Doctors' Surgery and Car Parking. Planning permission had (129/95)been granted. Materials to be used for external walls and for hard



surfaced areas and a landscaping scheme to be approved by SCDC. All planting to be carried out in first planting season following completion of development and trees/shrubs to be maintained for 5 years.

Details of hedgerows, trees to be retained to be submitted to SCDC. Landscaping scheme to include boundary hedging on the northern boundary.

Public car parking to include landscaping within it. Car park to be constructed before, consecutively or within two months following commencement of work on the surgery.

Noted that SCDC had lifted the covenant on this piece of land restricting use to recreation. SCDC's legal costs in relation to this to be met by MPC.

The manufacturers of the pump had confirmed in writing that there was enough spare capacity for connection to the doctors' surgery and also public toilets.

J.S. proposed and H.M.S. seconded therefore that Council withdraw its objection and allow the doctors use of the pump subject to a legal agreement and their payment of any upgrading if ever necessary. Carried by 10 votes in favour 1 against.

R.J.F. made suggestions concerning site operation. It was agreed that the committee meet the doctors and architect on Wednesday 31st May 7.30pm to discuss these matters.

Car Parking. J.S. proposed J.E.C. seconded and all agreed that Council ask three firms to tender for the contract to build a car park. The firms to be asked to Design & Build two options for a 64 space and also a 39 space car park.

On behalf of MCC I.L.D. agreed to ensure that the garages would be moved by 30th June to give the doctors vacant possession of the site.

It was agreed that MCC meet with MPC on 28th June 8pm specifically to look at the car parking.

and pointing out that Council was writing on behalf of all the people in the vicinity who were threatened by the fall out.

The clerk would also comment on the inadequate staffing levels of HMIP to monitor such sites. Copies of the letter to be sent to surrounding Parish Councils.
