Minutes of a Special Parish Council Meeting held on Monday 16 October 1989 at 7.30pm in the Community Centre.

Present: Mrs. L.M. Lock (in the chair), R. Day, Mrs. I.W. Chilton, Mrs. J.E. Coston, R.J. Farrington, J.F.C. Fisher, Mrs. S.J. Snaith, R.T. Summerfield, D.B. Waterson and the clerk S.J. Daniels

Apologies received from E.M.C. Dunlop and J. Harradine.

1. 379/89 Open Spaces. A reply from Customs and Excise pointed (359/89) out that the problem of a possible VAT payment was under review.

It was agreed that advice should be sought from tax counsel.

The clerk would inform N.A.L.C. of the position and C.J. Taylor of S.C.D.C.

R.T.S. proposed R.J.F. seconded and all agreed that Council pay K. Moore of Catlings half of his fee.

Monsell Youell were ready to negotiate a commuted sum for maintenance of their open space. The clerk would produce a figure for the November meeting.

Council had no objection to the playgroup building being sited on the old play area.

2. 380/89 Shopping Schemes. D.B.W. gave a resume of community car schemes in use throughout the county for such uses as: shopping, hospital visiting, transporting elderly and the disabled and any other special need.

Two types of scheme existed:

- 1. voluntary
- 2. assisted.

After a full discussion it was agreed that D.B.W. consult with W.R.V.S. to establish the need in Milton and produce recommendations for the November meeting.

3. 381/89 Chesterton Fen. J.E.C. produced a report on Chesterton Fen including a number of questions relating to caravan sites and the general appearance of the area.

It was agreed that this report be sent to S.C.D.C. including photographs and requesting a site visit from the E.H.O.

It was noted that S.C.D.C. resisted applications for caravans outside settlements unless there were special circumstances such as gypsy/accommodation for farm workers (min 279/89).

4. 382/89 Village Sign. A mock-up of the sign on hardboard was being produced. It was hoped to put a "real life" mock up on Pond Green in the new year.

Costs for materials amounted to about £800. Labour was voluntary.

It was suggested that small brass plaques commemorating Dr. Whitmore and K. Humphries be set into the plinth.

R.T.S. proposed that the volunteers' contribution be acknowledged in a time capsule set under the plinth. Agreed. Thanks were due to D.B.W. and his team.

J. Waterson's contribution to be discussed at subsequent meeting.

Village Cleaning Duties. It was agreed that the clerk would find out from Mr. Shipp if he was willing to tidy more areas in addition to present duties. Remuneration to be discussed at November meeting.

J.f.C.f. felt that Council should spend more on village cleaning and maintenance. He was concerned as new legislation was being proposed.

R.T.S. and R.D. felt it prudent to wait for the new proposals to be made law before acting on them. It was agreed to encourage various businesses to keep their frontages tidy and to ask the County Council what they regard as their responsibility for maintaining verges and roads.

The clerk to contact the E.H.O. about the continuing health hazard from the tyre burning on land beyond the industrial site.

S.J.S. would be willing to conduct another litter
