- 2. 23/90 Village Sign. L. Sandford produced a life size outline (382/89)of the sign together with post and base.

 It was agreed with one abstention that this design be approved.

 Thanks were due to L. Sandford for his work to date.
- 3. 24/90 Road Strategy. The re-draft of Council's response was (1/90) amended. It was agreed that the clerk send the final proof to the County Council with copies to the chair and vice chair of S.C.D.C. and also the chair and vice chair of S.C.D.C. Planning Committee. A copy of traffic statistics at the A45/A10 interchange was received from the County Council. The clerk would express Council's concern at the lack of information as supplied.
- 4. 25/90 Clerk's Correspondence Lion and Lamb Function Hall.

 Application for renewal of the public entertainment licence had been made to S.C.D.C. Council expressed concern at late night noise and disturbance from discos and vehicles to neighbouring properties.
- 26/90 Skateboarding. A letter requesting facilities for skateboarding was read out. This was passed to the Play Committee who were hoping to provide a tarmac surface on one of the play areas.
- 27/90 <u>Civil Protection</u>. A new civil protection course was planned for 1990.

(442/89) Permanent site to be reserved on site for turning and parking. Proposed garage to be made available for parking at all times.

- 30/90 S/1593/89 Perrys amended plans showing parking area (468/89) behind 8 High Street. For Information only.
 - 31/90 S/2613/89 Mr. and Mrs. Wilson 2 detached dwellings on plots one and two adjacent to 60 Old School Lane. No comments.
 - 32/90 S/2639/89 Dr. E. Draper, 3 houses at rear of 8-10 Cambridge Road. Unacceptable backland development. Insufficient parking for 3 new dwellings plus existing housing and business. Access on to Cambridge Road and opposite busy Coles Road junction too narrow and without footways. Land would be better used for more adequate parking for existing surgery.
 - 33/90 S/2672/89 Trinity College extension to social, recreational and conference centre at Science Park. No comments.
 - 34/90 S/2679/89 Mr. Boyd, Change of use (ground floor only) of 49 Cambridge Road to restaurant and two staces extension. Comments as per S.C.D.C.'s refusal decision to S/2293/89 (min.438/89) viz. Sevenfold increase in the amount of commercial floorspace would be undesirable intensification of use situation made worse by type of use proposed and likely unsocial hours of opening. Car parking arrangements unsightly and wholly inadequate. The noise and fumes from traffic manoeuvring in close proximity to the mobile homes would result in loss of amenity.

 It was noted that Mr. Boyd had appealed against this decision.

3. Any Other Planning Business

35/90 Letter from Mr. Spiers. Mr. Spiers pointed out that according to the legal department of S.C.D.C. he did not live in his caravan in fen Road while the finance department in registering him at this address for the community charge believed he did.
