APPLICATIONS FOR DONSEDERATION

2919 S/0465/76 Mr.&Mrs.J.Wilson, Old Rectory,Oxborough,Nfk. for: extraction of fill to be used in construction of new Northern By-pass - about 40 acres

S/0466/76 ditto - about 26 acres

HWHE declared an interest and his intention not to vote.

The Applicants' agent had written offering to help the Council and the Chairman had invited Mr. Hodge (of R.Arnold & Ptnrs.). Mr.Hodge said that about 800,000 cu.m. of embankment fill was required for this section of the By-pass scheme. If imported the necessary movement of vehicles wd. mean about 1 every 17 seconds; this app., if granted, would not involve using the village roads. Asked about back-filling he cd. not be committal about the length of time it would take to restore to agricultural use. Borings indicated this was a source of at least 30 feet of dry clay - ideal for the purpose. He agreed the site would be fenced during extraction work.

Members discussed the application at length. They agreed it would relieve the village of lorry traffic (although the suggested rail transport from a distance wd. do the same); it wd. be well away from the village 'envelope' and pits here would have less visual impact on village life than, for instance, pits dug in Milton Fen.

On the other hand it represented a degree of detriment to the environment which would be visible from the new by-pass; an open pit would be left - probably for a very long time which could become a refuse tip or an opportunity for local rubbish dumping.

Each member expressed his individual view.

On prop: MEJ; sec: MW it was AGREED to approve extraction from the 26-acre proposal (S/0466/76) with conditions and to oppose firmly the 40-acre proposal (S/0465/76) on the grounds that the extra 14 acres - which would be all on the village side of the Mylton By-pass - would be too close to residential property and was the better farmland. On the vote being taken it resulted 4/0 in favour of the motion. The view of an absent member, GEP, was then mentioned by the Chairman: this was in favour of the 26-acre proposal.

The conditions to be returned to the Planning Office were agreed as follows:

- (i) adequate screening during excavation with tree-planting in the long-term if possible.
- (ii) If possible every effort to be made to avoid use of the pit as local authority refuse tip; and also indiscriminate rubbish dumping.
- (iii) Back-filling to be expedited as much as possible.

He had taken advice from the Chief Executive Officer of SCDC, &Mr. Martindale and (on the latter's advice) from the District Auditor and it would appear that the suggestion (see MIN: 2911) of offering Mr.B. Connor the post of Clerk would have to be carefully re-considered. AGREED to do this.

Meanwhile, also AGREED, the present Clerk be asked to put back his resignation. The Clerk was very happy to do so and again expressed his willingness to continue for amyindefinite period - several months if necessary.

AGREED, the situation be reviewed at the next meeting, May 10th.

2924 STREET LIGHTING The County Council had sent a schedule of lamps

ECONOMIES >NOT - in the parish to be swithhed off as economy

ICE OF SWITCH- measure amounting to about 50%. The Clerk had made inquiries from which it appeared this was now adopted County Council Policy under Govt. directive the aim of which was to save both energy and costs; he also understood all white tungsten lamps were to be eventually replaced by sodium vapour lamps which gave equal light putput at about one-third energy consumption.

The Council carefully considered the schedule and members agreed to check this in their own area and to let the Clerk know by Monday, 26th. April if they disagreed with the schedule.
