2201 - CIRCULATED MINUTES OF MEETING OF JUNE 19 last were confirmed and signed by the Chairman

MATTERS ARISING FROM THE MINUTES

2202 - LAND AT BUTT LANE The Co. Surveyor had written, on 27nJune, CORNER (2177) saying he would take 'remedial action' on the weed nuisance on the corner.

Regarding the future of the plot he said negotiations for the sale by the Dept. of the Emvironment would shortly commence.

2203 - WASTE LAND, Title documents still awaited from the solicitors.

COLES ROAD The Clerk had written to Messrs Few and Kester

(2178) voicing the Council's concern over the delay about the title and asking for an early azsurance together with the necessary documents for signature.

2204 - STATE OF THE HALINGWAY work had not yet been done he had hopes that it would be done very shortly when (he understood) the Conservators were to pipe a length of ditch at Baitsbite Lock.

2205 - LITTER While awaiting delivery of the litter baskets on order (2183) it was agreed the litter problem near the War Memorial and shops was still acute.

It was also agreed the Scouts and Guides be asked if they would be prepared to occasional voluntary collections and the Clerk was instructed to write accordingly.

2206 - STATE OF CERTAIN Recent repairs requested to paths and Fen rd.
HIGHWAYS (2186) (near river) now having been completed the
Chairman asked that the Clerk send a letter
of thanks to the Co. Surveyor's Dept. Agreed unanimously.

The Co. Surveyor, on 3 July, doubted that the length of footway leading to Coles rd. entrance to Rec. Grd. was adopted but agreed to give attention to it (and had done so).

2207 - FOULING BY The following wording was agreed for Notices to be DOGS (2189) erected at each entrance to the Rec. Grd. -

"Please keep your dogs from fouling the Children's play and sports areas".

Mr. Easy agreed to erect these when completed.

2208 - PARISH TREE-PLANTING It was agreed that the Clerk write to the 1973/74 (2190) County Surveyor for permission to plant trees on the grass verge near the corner of the Industrial road (near Cambridge Rubber Co. new factory)

At the same time he was to approach Mr. Kaye (of the Rubber Co.) offering some trees if they would plant and maintain them.

2209 - PUBLIC TOILETS AND Mr. Kiddle reported that the proposals for CHANGING-ROOMS changing booms was being received enthus-cally (2091) 9200A

iastically by both the Football and Cricket Clubs and the Village Hall Committee. Fund raising was being considered by a joint Committee of both Clubs.

2210 - MILK BOTTLE RECOVERY The Clerk reported he had seen the local Manager who regretted he could take no action in securing the numerous gaps in

the Rec. Grd. hedge which gave children access to his side of the hedge; he would try, however, to block any further entry to his premises from his side. The Council agreed to leave the matter in abeyance unless further complaints of broken glass on the Grd, were recd.

- 2211 1973 AUDIT The Clerk reported the Auditors' verbal comments; (2187) one of the matters was still being resolved.
- (i) The Assistant District Auditor had questioned the Clerk's salary increase granted in February last (MIN. 2089). A meeting of some members of the Council and the District Auditor had taken place a few hours before this meeting. The Council discussed the matter further and agreed to defer any decision until after a Special Meeting to discuss the matter, on 11 or 18 september, next when it was hoped all members would make a special effort to attend. (This would follow the regular meeting on September 4).
- (ii) Village Hall Fire Insurance: The Ass. D. A. suggested that, as many other parishes did, the Council pay this Insurance premium (directly to the Insurers) recovering the amount from the Committee of Management as rent for the Village Hall (owned by the Council). He suggested that both the matter of the Hall insurance and its

He suggested that both the matter of the Hall insurance and its periodic re-valuation be discussed annually as a special item of Parish Council business.

The Clerk had sought Mr. Martindale(s opinion who felt, quite strongly, the Committee of Management were adequately empowered by their Constitution to pay all Hall insurances and, indeed, it was the a Management duty to do so. The Council's powers, as Custodian Trustees were, he felt, to see the Committee's Constitution was adhered to and carried out.

The Council agreed unanimously to accept Mr. Martindale's interpretation.

They further agreed unanimously to instruct the Clerk to put the Village Hall insurances as an item on the Council Agends at their meeting immediately following the due date of the Hall insurance premiums (to be obtained from the Committee Secy.).

- 2212 CONCESSIONARY'BUS Leaflets had been received from the C.R.D.C PASSES (2075) announcing revised arrangements for concessionary fares: reductions were now obtainable at ages 65 or over. The Clerk reminded the Council that Mrs. K. Edwards had already agreed to hold copies of leaflets for inquirers,
- 2213 SHIRLEY LODGE (i) Agreed hedgerow: the Clerk had written, estate (2011) on June 23, to remind Messrs H.C. Moss that the hedgerow agreed to be planted on the Estate/Old School Lane boundary in January, 1972 had not yet been done. He had received their apologies and fresh assurances on July 3 that it would be planted "as soon as possible".
- (ii) States of nearby path: Mrs. Chinnick said that the pathway running alongside the hedgerow in (i) was being used by cyclists and motor cyclists to the danger of the public, particularly so at each end where there were blind right-angle.

The Clerk said he understood the pathway was the developer's private path for Estate residents' use but could not comment if vehicles were entitled to use it or not. He would enquire of Messrs Moss.

The Clerk drew members' attention to the recent Press reports about Mr.G. Townsend (80) who had fallem into the pit and narrowly escaped drowning. Mr. Townsend was saved by the timely action of Mrs. S. Summerfield
