MINUTES OF A MEETING OF MILTON PARISH COUNCIL HELD IN THE VILLAGE HALL ON MONDAY, 24TH NOVEMBER, 1958, AT 7.30 P.M.

MINUTES.

The Minutes of the meeting held on 23rd September, 1958, were read, confirmed by the Meeting and signed by the Chairman.

MATTERS ARISING FROM MINUTES.

Village Hall - The Clerk reported that he had received remittances from Cambridgeshire County Council as follows:-

> £26. 4s. Od. rent for use as schoolroom 15. Od. scrubbing the hall 41. 5s. Od. proportion of electricity used.

£68. 4s. Od.

These amounts, which represented the total indebtedness of the County Council, had been handed over to the Village Hall Committee of Management.

Street Lighting - Fen Road. - The Clerk reported the receipt of a letter from Chesterton Rural District Council to the effect that priority was being given to those parishes which do not enjoy street lighting facilities. This confirmed the information given by the Chairman at the previous meeting.

The Clerk also reported that the County Surveyor had written to say it was doubtful whether it would be possible to provide for the reconstruction of a further length of Fen Road in next year's programme, although he agreed the work was desirable.

After consideration of this correspondence the Clerk was instructed to again write to the Chesterton Rural District Council stressing the importance of , providing further street lighting covering the new development in Fen Road, in the interests of public safety.

Eastern Counties Omnibus Company - The Eastern Counties Omnibus Company had been able to obtain some figures in regard to the number of passengers unable to board buses at Milton, but they were still investigating the matter.

HOUSING DEVELOPMENT AT MILTON.

Information had been received from the County Planning Officer that an application from Messrs. Aubrey Bell Limited had been received for the development by private enterprise of the whole of the land designated for purchase by the Chesterton Rural District Council

for housing. It had been possible for the applicant to obtain control of all the land, and subject to the concurrence of the Ministry of Housing and Local Government, planning permission would be granted.

The Clerk was instructed to obtain a plan of the suggested layout.

No action was proposed in an appeal by the Cambridgeshire Fund for the Blind as a house-to-house collection had already been made in the village this year for this cause.

ANY OTHER BUSINESS.

Street Lighting Failures.
