



MINUTES.

The Minutes of the meeting held on 26th July, 1960, were read, confirmed by the meeting and signed by the Chairman.

MATTERS ARISING FROM MINUTES.

527.

Local Government Commission Draft Proposals - Petition.

The Clerk reported that the village had been canvassed and that as a result he had forwarded to the County Council ten pages of signatures of parishioners opposing the draft proposals.

528.

Allotments - The Clerk reported that subsequent to the last meeting he had received notification from the County Council Smallholdings Committee that a review of Smallholdings rents had been carried out and as a consequence the Parish Council was asked to agree to an increased rent of £47. 0s. 0d. per annum in respect of the allotments hired from the County Council, such increase to be effective as and from Michaelmas, 1961. The Chairman's action in agreeing the increased rent was confirmed. The Clerk further



reported that he had subsequently queried the acreage being charged by the County Council and as a result the amended rent would now be £46. 10s. Od. per annum.

It was agreed that the Council's allotment tenants be charged a rent of £4. 4s. Od. per acre per annum as from Michaelmas, 1961, and that the Clerk notify them accordingly.

BEST KEPT VILLAGE COMPETITION.

The Clerk reported that the Fairhaven Trophy had been presented to the winning village - Chippenham - on 17th September. The runners-up being Girton, Orwell and Duxford.

LAND AT CAMBRIDGE ROAD, MILTON.

The Clerk reported that the Minister of Housing and Local Government had accepted his Inspector's recommendations and refused the applications of Sundesine Limited, Mr. D. Sutherland and Mrs. and Mrs. D. Doggett, who had appealed against the refusal of the County Planning Committee to develop the land. The Minister did so, however, without prejudice to the consideration by the local planning authority of a revised application for the development of the frontage land based on a comprehensive layout and designed to further the objectives of the county development plan, i.e. by providing for the re-location of non-conforming or badly sited industry within the city of Cambridge.

MILTON FOOTBALL CHARITY CUP.

The Clerk read a letter from the Chairman of Milton Football Charity Cup deploring the poor support from local people at the semi-final and final matches in this competition. It was hoped that in future the interest of Councillors and residents could be enlisted in order that more funds could be made available for distribution to local activities.


