MATTERS ARISING FROM MINUTES.

273. Gravel Pit Pasture - The Clerk reported that the Chesterton Rural District Council were to invite offers for the land by advertisement in the local press.
274. Council House Garden Competition.- The Chairman reported that Mr. A. W. Wenham, 22, Bene't Close, had won the Council House Garden Competition.
275. Litter Bins - The Chesterton Rural District Council stated that the firm supplying these was dependent on the revenue which could be obtained from small advertisements attached to the bins. Until the response from advertisers was known it was not possible to say when the bins could be provided.
276. COUNTY OF CAMBRIDGE DEVELOPMENT PLAN. TOWN MAP NO. 2 FOR THE AREA SURROUNDING CAMBRIDGE.
- The Clerk submitted the Town Map, Programme Map and Written Statement which had been received from the County Planning Officer and which had now received the approval of the Minister of Housing and Local Government.
277. NATIONAL PARKS AND ACCESS TO THE COUNTRYSIDE ACT, 1949.
- The Clerk reported that he had received the Definitive Map and Statement of Public Footpaths and Bridleways, which were to be made available for inspection until 10th August, 1957.
- The Act requires that the Definitive Map shall be reviewed every five years and as the relevant date of the first Draft Map was 4th October 1952, the revised Draft Map must be published before 4th October, 1957.
- The Act further requires that a parish meeting shall be held to consider the information relating to the review of the map and it was accordingly agreed that a Parish Meeting be called for Tuesday, 20th August, for this purpose.
