Matters arising from Minutes

89. Recreation Ground. An assurance was received from Milton Football Club that they would pledge their full support to the Council in any effort to raise money towards purchasing a playing field.

90. Doctor's Surgery.
The Clerk reported that Dr. Hartley of Waterbeach had made arrangements for his assistant, Dr. H. B. Whitmore, to hold a surgery at Byhill Close, Fen Road, on Monday and Thursday mornings, commencing on 2nd December 1954.

91. Bus Service
The Eastern Counties Omnibus Company hoped that by a re-arrangement it would be possible to provide a relief vehicle for the 8.30 a.m. journey from Milton.

92. Overhanging Hedge and Trees
The Clerk reported that the hedge at Teversham Close had been cut down. Regarding the overhanging trees at Willow House, the County Surveyor had replied that most of the trees were well back from the footpath and did not cause any obstruction to users of the highway nor any appreciable interference with visibility at the bend.

He did not, therefore, consider the highway authority would be justified in taking any action.

Mr. Siggs raised the question of lighting for the bus shelter and the Clerk was instructed to make enquiries of the Eastern Electricity Board.

97. Development of Frontage O.S.P. 220 Doggetts Gravel Pits.

No objections were raised to a proposal by Mr. D. C. Doggett to develop part of O.S.P. 220 fronting Cambridge Road, for industrial purposes.

98. Parish Notice Board

The Clerk sought permission for the erection of a Notice Board on the wall inside the bus shelter at the Men's Institute to replace the present notice board erected on the Green which is badly in need of repair. Instructions were issued for this to be done.
