- 1. R.T.S. read the minutes of the meeting of 24 January 1994. It was noted that the Committee at that meeting anticipated a precept of £50,000 for 1995/96.
- 2. Precept 1995/96. The clerk had estimated expenditure of £59,000. It was agreed that play equipment should be met out of commuted sums and interest. In arriving at a figure the following assumptions were made:
 - Car park replacement no extra cost as this should be met out of funds received from the doctors. Any future extension to be discussed with M.C.C.
 - 2. Traffic calming no cost as any measures were uhlikely to be implemented within 12 months.N.B. Council are limited to an expenditure not exceeding "No. of electorsx £3.50 in any financial year.
 - 3. Clerk's Salary C.F.N. proposed D.T.W. seconded and agreed to recommend that the clerk become a "busier" part time clerk i.e. working a minimum of 15 hours per week. This would cost between £400 and £1000 per year extra. A contract of employment to be drawn up and presented to Council.
 - 4. Up to £1500 to be provided for a computer and printer for the clerk.

R.J.F. proposed D.T.W. seconded and all agreed that the Committee recommend that Council precept for £50,000 for the year 1995/96.

3. Manager's Salary M.C.C. The clerk to liaise with M.C.C.

There being no further business the meeting ended at 9pm.
